

15 **JUDGMENT**

16 The Defendant, having entered a plea of Guilty, and no sufficient cause being  
17 shown as to why judgment should not be pronounced against him, the Court rendered  
18 judgment as follows:

19 That Jacob Daniel Gosselin is guilty of the crime of Attempted Murder With  
20 the Use of a Deadly Weapon, a violation of NRS 193.330 and NRS 193.165, being an  
21 attempt to violate NRS 200.010, a category B felony, as charged in Count II of the  
22 Information, and that he be punished by imprisonment in the Nevada Department of  
23 Corrections for the maximum term of twenty (20) years with the minimum parole  
24 eligibility of seven (7) years, with credit for two hundred eleven (211) days time served.  
25 The Court further imposes an additional penalty of a consecutive term of imprisonment in  
26 the Nevada Department of Corrections for the maximum term of twenty (20) years with  
27 the minimum parole eligibility of one (1) year for the deadly weapon enhancement.

28 ///

1           That Jacob Daniel Gosselin is guilty of the crime of Conspiracy to Commit  
2 Robbery, a violation of NRS 199.480 and NRS 200.380, a category B felony, as charged in  
3 Count III of the Information, and that he be punished by imprisonment in the Nevada  
4 Department of Corrections for the maximum term of thirty (30) months with the minimum  
5 parole eligibility of twelve (12) months, to be served concurrently to the sentence imposed  
6 for Count II, with credit for two hundred eleven (211) days time served.

7           The Court, having found that the penalty imposed for the deadly weapon  
8 enhancement be served consecutively to the underlying sentence imposed for Count II,  
9 finds that the maximum aggregate term of imprisonment in the Nevada Department of  
10 Corrections is forty (40) years, and the minimum aggregate term of imprisonment is eight  
11 (8) years.

12           It is further ordered that the Defendant shall pay the statutory Twenty-Five  
13 Dollar (\$25.00) administrative assessment fee; that he shall submit to a DNA analysis test  
14 for the purpose of determining genetic markers and pay a testing fee in the amount of One  
15 Hundred Fifty Dollars (\$150.00); that he shall pay the Three Dollar (\$3.00) administrative  
16 assessment fee for obtaining a biological specimen and conducting a genetic marker  
17 analysis; and that he shall reimburse Washoe County in the amount of Five Hundred  
18 Dollars (\$500.00) for legal services rendered.

19           It is further ordered that the fees shall be subject to removal from the  
20 Defendant's books at the Washoe County Jail and/or the Nevada Department of  
21 Corrections. Any fine, fee, administrative assessment, or restitution ordered today (as  
22 reflected in this Judgment) constitutes a lien, as defined in NRS 176.275. Should the  
23 Defendant not pay these fines, fees, assessments, or restitution, collection efforts may be  
24 undertaken against him.

It is further ordered that Murder of the First Degree with the Use of a Deadly Weapon, a violation of NRS 200.010, NRS 200.030, and NRS 193.165, a category A felony, as charged in Count I of the Information, is hereby dismissed.

Defendant acknowledged receipt of the Information; waived reading. Defense counsel stated the plea negotiations; State's counsel concurred with the recited negotiations.

**COURT** noted that the Waiver of Preliminary Examination states the plea negotiations correctly with regards to the titles of each Count, however the Count numbers are incorrect.

Defendant sworn and fully canvassed by the Court as to his rights.

*During the Court's plea canvass, the Defendant requested time to speak to his attorney privately; matter trailed.*

When the case was recalled, the Defendant was further canvassed regarding his rights.

*Defendant again requested to speak to his attorney privately; matter trailed.*

When the case was recalled, Defense counsel gave the Court information regarding the Defendant's questions.

Defendant was further canvassed by the Court.

**COURT** read aloud the charges contained in the Information.

Defendant entered plea of guilty to Murder of the First Degree With the Use of a Deadly Weapon as charged in Count I of the Information; Attempted Murder With the Use of a Deadly Weapon as charged in Count II of the Information; and Conspiracy to Commit Robbery as charged in Count III of the Information. Court accepted plea after finding that the Defendant was freely, voluntarily, and competently entering such plea and had been fully advised by counsel.

**COURT** noted that the trial in CR20-0308, State vs. Daniel Munoz-Negrete, is set to begin on August 23, 2021. *(This trial is set in Dept. 6 for 13 days.)*

**COURT ORDERED:** Sentencing is set for September 20, 2021, at 9:00 a.m.

**COURT ORDERED:** Defendant shall cooperate with the Division of Parole and Probation in the preparation of a PSI.

**COURT FURTHER ORDERED:** Matter referred to the Division of Parole and Probation for PSI and continued for entry of judgment, consideration of probation report and imposition of sentence.

Defense counsel advised the Court that there is an agreement between the parties that the Defendant can be released on his own recognizance with Pretrial Services supervision and GPS monitoring, and he presented argument in support of this request.

State's counsel concurred with Defense counsel, noting that he has stipulated to the Defendant being released from custody pending sentencing.

**COURT** noted that the Defendant has just pled guilty to first degree murder with a deadly weapon, as well as two other serious charges, and now the attorneys are requesting that the Court release him from custody, with absolutely nothing in the file to support this request.

Officer Pitt gave the Court information regarding the Defendant's previous performance on Pretrial Services supervision, noting that he was not interviewed following this arrest due to the nature of the charges.

Discussion ensued between the Court and respective counsel regarding sentencing and the Defendant's custody status.

**COURT ORDERED:** The joint request that the Defendant be released on his own recognizance is DENIED. Defense counsel is free to file a written motion on the issue, and a hearing will be set for May 24, 2021 at 2:00 p.m. Defendant remanded to the custody of the Sheriff.

**HEARING ON DEFENDANT'S MOTION FOR O/R RELEASE**

Chief Deputy District Attorney Luke Prengaman was present on behalf of the State.  
Defendant was present with counsel, Sean Neahusan, Esq.

*Pursuant to the national and local COVID-19 emergency response that caused temporary closure of the courthouse located at 75 Court Street in Reno, Washoe County, Nevada, this hearing was conducted remotely. This Court and all participants appeared electronically via Zoom Webinar. This Court was physically located in Washoe County, Nevada.*

**COURT** reviewed the procedural history of the case, noting that he has reviewed the Defendant's Motion for Own Recognizance Release, filed May 21, 2021, and it does not give him very much information.

Defense counsel presented argument in support of the Motion.

State's counsel gave the Court information regarding the Defendant's criminal history, and he summarized his reasons for agreeing that the Defendant be released on his own recognizance pending sentencing.

**COURT** set forth findings of fact and conclusions of law, noting that he can discern no benefits and only risks to the safety of the community if this Motion was to be granted.

**COURT DENIED** Defendant's Motion for Own Recognizance Release. Defendant shall remain in custody pending sentencing.

Defendant remanded to the custody of the Sheriff.
