1. Procedural Background

On December 28, 2021, following a preliminary hearing in Justice Court, Max Mones was arraigned in District Court Dept 6 on two (2) counts of Duty to Stop at the Scene of a Crash Involving Death or Injury, which is governed by NRS 484E.010, and one (1) count of Failure to Stop in Obedience to a Stop Sign, which is governed by NRS 484B.257. He entered not guilty pleas to all counts.

On February 3, 2022, Mr. Mones, through counsel, filed a Petition for Writ of Habeas Corpus. On February 9, 2022, the District Attorney filed a response. A hearing was held on the matter on February 22, 2022, and both parties made oral arguments. The Court then denied the Petition.

A trial date of May 16, 2022, was initially set, with a calendar call on May 10. Upon the motion of the defense, the date was continued to a trial date of November 14, 2022, with a calendar call of November 8, 2022. A status check on trial readiness was also set for September 22, 2022.

2. Decision by the Court

At the February 22, 2022 hearing, Mr. Sablanos appeared on behalf of Mr. Mones. By way of highlighting the points made in his Petition for Writ of Habeas Corpus, he argued that no evidence had been presented to show that Mr. Mones had actual knowledge that an accident had occurred; thereby negating his duty to intervene. He argued that the State had presented zero testimony or physical evidence which could meet even the slight or marginal standard. The State responded that they had presented a witness, who was a passenger in Mones' car, who had heard a very loud sound, and that the dashcam footage it presented far surpassed the legal standard to defeat a Petition for Writ of Habeas Corpus.

The Court found that the evidence presented by the State at the preliminary hearing met the standard of slight or marginal evidence, and that each piece of evidence presented would need to be evaluated by a jury. Based on that, the Court denied the Petition.
