1. I am an attorney employed by the Nevada Attorney General's Office, and I am counsel of record for the Respondent in this matter.

2. I respectfully request an extension of twenty-one days, to and including November 29, 2022, which is necessary for me to effectively represent the Respondent's interests in this writ proceeding. This is the first request for an extension of time to answer the petition.

In addition to completing ordinary day-to-day tasks, since this Court ordered a response to the writ petition in this matter, I have remained extremely busy addressing time-sensitive issues in the appeals this Court consolidated under *Sullivan, P.E. v. Lincoln County Water Dist.*, No. 84739, drafting an emergency writ petition in *Department of Public and Behavioral Health v. Eighth Jud. Dist. 2022, and she indicated that she has no opposition to Respondent's request for additional time.
