

Statement of Facts. Briefly explain the facts related to your request for a stay. (Your answer must be provided in the space allowed.)

This is now my 6th appeal to Nevada Supreme Court after providing very clear evidence of the Forgery and Fraud committed against me to obtain the Marital Home. Nevada Supreme Court has Illegally allowed 6 appeals into this matter completely ignoring the misconduct of Jennings and Fulton and Shumway Van law Firm. Garrett Chase has failed to recuse and should have never taken over this matter after Grayson Moulton was disqualified. I have proven and provided clear evidence of the legal malpractice of Garrett Chase, and there has been no hearings since May of 2020, so how is he claiming that he is doing \$80k of work. Bobby Antee illegally entered my residence, stole over \$30k of my property and then listed the home for sale with liens on the title. I have now lost all my personal property, all monies stolen from me to purchase the home, and the slander from Bobby Antee, Realtor Linda Naw, and their shared counsel, Garrett Chase has now caused over \$300k in losses for my foundation that I run honestly to HELP SICK CHILDREN. I was married to Bobby Antee for 2 months, this litigation has now been drug out for nearly 6 years by Garrett Chase, who refuses to communicate with me. So again, how is he accumulating these fees, and why is the Supreme Court allowing a victim to be abused, stolen from, and attacked? These are not functions of a Judicial System, and not even humane. I provided the court with clear evidence that the home could be put into my name since I was the only person who contributed to the home financially. Bobby Antee stole \$26k and paid off his entire life, he was awarded all community property, committed a federal crime and yet the District Court, Supreme Court, and Family court have all protected him to protect Brokers Jeff Moore and Tracy Bouchard. I have been denied my right to a jury, to due

process, to representation as a victim of a crime. My Sole and separate funds have been withheld from me for 6 years while you all play games and abuse your power. My family has been publicly attacked and resources that my disabled mother needs have been refused to us, to protect your corruption and clear organized crime. My judge was change from Kathy Hardcastle after reporting the Notary Fraud of Nikki SIklais Bott to Judge Rena Hughes, a judge known for corruption and abuse. Kathy Hardcastle's husband Gerald Hardcastle then attempted to label me vexatious, again trying to refuse my right to be heard and to due process. My case was then again change to Judge Dawn Thorne who has never held a hearing and continues to award fees in retaliation, which is a felony and illegal to retaliate against a victim. Every Supreme Court Judge has been served with Civil Rights Complaints and have failed to recuse. While you all play these games with my life, my family is suffering, my work is being destroyed, and the only people being protected are the criminals, corrupt officials, and dirty lawyers all at my costs. Realtor Linda Naw was Bobby Antee's only witness where she perjured herself on the stand with multiple lies, including that they had gift letters for his debt in which they did not. In fact, Bobby Antee admitted to defrauding me, and attending the closing on his own and fraudulently accepting conveyance into his name. Broker Jeff Moore funded the loan prior to Bobby Antee ever being approved which is also very clear proof of Mortgage Fraud. I have reported this grand Larceny to the IRS in which you all continue to steal from me and claim these fees as earnings and income, which is a lie, you are all stealing from me, denying my right to my property, and a fair trial. I will continue to take this matter to Federal Court, if this court continues to ignore evidence and allow Shumway Van to continue to stalk, harass, and steal from me and my family.

Effect on Your Appeal. If a stay is denied, how will this affect the issues you are appealing? (Your answer must be provided in the space allowed.)

There is no legal reason why the Nevada Supreme Court should have sat and watched this abuse for over 3 years now and have failed to ensure I am treated fairly, and justice is served. This is a twomonth marriage that has now been in appeals for nearly 3 years, with no one doing anything to protect my rights. Denying the stay will simply allow the extortion and abuse to continue and ensure that my family suffers, my work, and the hundreds of children I help. This is a criminal case that is being litigated in family court by judges who do not have jurisdiction over home/ title fraud. Nevada Supreme court has allowed Shumway Van to break every law and is now also trying to force me to pay them for abusing me and the legal system? Why is Bobby Antee not paying his own legal fees from his attempt to conceal his crimes? This Court can continue to try to conceal the abuse I have suffered but I will also continue to file federal and Bivens complaints and a Writ or Certiorari to the US Supreme court until I get justice for what has been done to me, the memory of my son, and my mother. It has been made very clear to me that the State of Nevada is not capable of handling this matter fairly or upholding the law, so I will take this all the way to Washington DC and continue to publicize the abuse I am enduring. I won this case in May of 2020 pursuant to NRS 205.170 and NRS 240.065 (b), so ignoring the evidence and allowing the endless extortion and abuse wont stop me from seeking justice.

Harm to You. What serious harm will you experience if a stay is denied? (Your answer must be provided in the space allowed.)

What I have gone thru is despicable and horrific, that the same people entrusted with protecting the community and the constitution are the same people ensuring that justice is not served. I have now lost 6 years of my life. I have been attacked by 100's of people who have come together to protect these brokers and their crime family associations. My husband and son have been attacked by realtor Linda Naw and her Blogger which accused him of assault, which is malicious Prosecution. I had to close my foundation in Nevada and relocate the foundation completely alone, loosing much of our support and costing me thousands of dollars. I had to pay rent in a new home, when I already had a home that should have been transferred to me and the Title Quieted thru the multiple Lis Pendens Filed then Illegally removed without hearings or due process. I have lost all of my personal belongings in the home, including medical equipment my mother still hasn't been able to replace. I lost the entire \$98k taken from me to purchase the home illegally, I lost the \$37k in mortgage payments I made alone, while the trial was delayed, and judges were constantly switched to fulfill an agenda. I have had to cash out my retirement to pay for legal fees and defend myself as a victim of a crime. I was rapped in the home, then forced to live in the home for another year while the trial was delayed and Adam Fulton, Logan Wilson, Chris Tillman, and Jared Jennings conspired with Garrett Chase, Michael Van, and Grayson Moulton. This has all gone on while the Nevada Supreme court has been over the matter and multiple appeals. Clearly seeing that the lower courts were not following the law or judicial procedure. My foundation went from raising over \$200k year to help Cancer Families to this year raising \$2k, and in danger of simply closing. One person being abused by 100's isn't even a fair fight, and since when does the "MOB" attack innocent women, children, and elderly. This is a disgrace to the justice system. The damage that has been caused to Aydens Army of Angels, the last piece of my son Ayden is becoming unrepairable, and why, because Linda Naw and Bobby Antee couldn't just cancel the purchase as I requested? SO, I then deserve this abuse for simply asking for the law to be upheld? I am being forced to serve every motion to the people abusing me, in which they should have their Licenses revoked and all law firms should be shut down, yet they are being permitted to continue their attacks, abuse and theft by the highest court. If this continues and my separate funds continued to be held by lawyers who are committing fraud and steal legal fees, they haven't earned my family will have no where to live, my business will be closed and the resources I bring to children honestly will be gone. Criminals will continue to walk free and expose the mass corruption in the State of Nevada. I will continue to fight for justice no matter how long it takes me and will expose every single judge and lawyer who is part of this scandal until God decides its time for me to return home to my son. I do not fear any of you, I am Gods Child and trust his plan for me, even if it includes suffering years of additional abuse by the Nevada Justice System. If this court continues to fail to ensure that I am not made whole, I will have nothing left for simply being a victim of fraud. I have full faith that God will have the final say, and this empire of corruption will soon fall and be held accountable for the many people you have all hurt.

Harm to Others. What harm will the other side experience if the stay is granted? (Your answer must be provided in the space allowed.)

For the last 5 years, I am the only caregiver for my fully disabled mother. I must prepare her meals, bathe her, change her diapers, help her walk, and I have done all of this while helping hundreds of Cancer Families, and defending myself against a system built to fail me. I have had to work nights, cash out my savings, retirements, sell my cars, and jewelry, to make sure my mother has the things she needs and that my foundation remains open and helping families. This entire time, Shumway Van and Bobby Antee have had full control over monies that belonged to me and my son and could have given my mother the proper medical care that she needs. My husband and son have been attacked at a horrible attempt to damage my character, which didn't even work. They have been forced to live in poverty when I should have had plenty of resources to provide for my family. The families of Garrett Chase the 30 judges now involved, the reputation of the courts and government workers have all suffered to protect Jeff Moore and Tracy Bouchard. The mass corruption in the US court systems have been grossly exposed by a scheme to defraud a mother who lost a child and simply wanted an annulment. Bobby Antee has been used by Shumway van to fulfill their agenda and will forever be known as a scammer and a man who could not provide for himself. The multiple clerks and records agents will now have to live with the fact that they were part of attacking an innocent woman because Shumway van couldn't admit they lost a case. The fact that a Pro Sec litigant has no rights in a court room, even though the constitution states they do is now clearly exposed. Hundreds of News stations now know of the misconduct of the Supreme court, in which there is nothing honorable about anyone involved in this matter. The families of these lawyers and judges now face the embarrassment of what their loved ones truly do at work and how many people they hurt to fulfill their agenda. My son's legacy has been overtaken by corruption and abuse, and I a mother who lost a child and simply became a victim of fraud has had to suffer this all alone. I am now 39 years old and have two more years to seek IVF, yet this case refuses to conclude so I could use MY MONEY to have another child. This is evil, and only work of Satan himself, yet you all swear oaths on a bible. Bobby Antee's mother has now supported a grown man for 5 years while you all go against everything, she states she stands for and sins that God will not look past. This could have been done years ago, by simply forcing Bobby Antee to repay the student loans, I would have never investigated it further, yet you were all so greedy and arrogant that it exposed the entire system of corruption and patter of judges committing these crimes.

Success on Appeal. Why are you likely to win this appeal? (Your answer must be provided in the space allowed.)

I already won this appeal in 2020, the only reason we are still here doing this, is because of Abuse of Power, Corruption, Legal Malpractice, and egos. A group of men and woman who have no regard for law or the constitution they promised to uphold. A group of "leaders" who believe they are above the law and would rather take political favors and bribes then protect a victim. A group of women Judges who have no ability to make their own decisions yet are told what to do by Men who have no regard for them either. NRS 205.170 says an expert proves forgery, NRS 240.065 (b) states a notary can't also be the title agent, and the multiple levels of civil rights violations clearly show I won this case and appeal. The fact that you all continue to ignore it, doesn't change the facts and the ability of the public to see exactly what is truly happening to me. I will take this matter to the US Supreme Court in Washington, if this court feels they can continue to violate my rights and inflict continuous harm upon me, my family, and my work. In two years I will have completed law School and you will never be able to refuse my right to be heard and to justice again. Bobby Antee, Linda Naw and Nikki Bott will be in a federal prison for the crimes they have committed, no matter how much this court tries to protect them from accountability. I have done nothing wrong, I give back to my community,
