

Dear Clerk of the Supreme Court

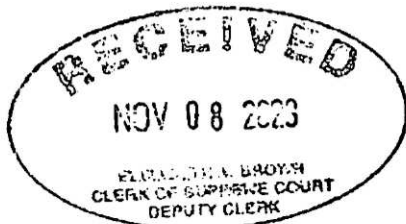

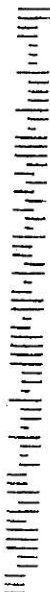

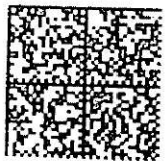

ORDER
