Plaintiff obtained default judgment against DRIBBLE DUNK, LLC and ALL NET, LLC after they failed to answer. Plaintiff had a pending motion for partial summary judgment against Robinson which was not heard, as the Court granted Defendants' Motion to Dismiss prior to the hearing. Plaintiff/Appellant is therefore appealing the District Court's Order Granting Defendants' Motion to Dismiss or in the Alternative Motion for a More Definite Statement, entered on August 12, 2022, and any and all orders made appealable thereby.
