This motion is made and based upon the attached affidavit and certificate.

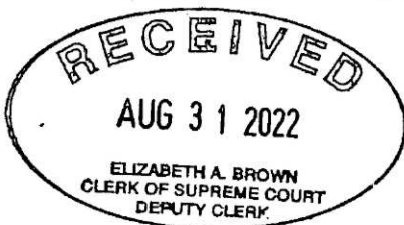
