
## IN THE SUPREME COURT OF THE STATE OF NEVADA

## ORDER GRANTING MOTIONS

Respondent has filed a motion to associate attorney Robert Daniel Friedman in this matter pursuant to SCR 42. Attached to the motion to associate Mr. Friedman is a verified application, certificates of good standing from the Appellate Division of the Supreme Court of the State of New York and the District of Columbia Bar, and a Supreme Court Rule 42 statement. The Rule 42 statement of the State Bar of Nevada indicates that Mr. Friedman has not applied to appear in Nevada courts within the last three years. *See* SCR 42(6) (repeated appearances by any person or firm pursuant to this rule shall be cause for denial of a motion).

The motion is granted. Mr. Friedman shall be permitted to appear on behalf of respondent in this appeal. Nevada attorney Matthew L. Sharp, of Matthew L. Sharp, Ltd., shall be responsible for all matters presented by Mr. Friedman in this matter. *See* SCR 42(14); NRAP 25(a)(5) (all documents submitted to the supreme court for filing by a represented party shall include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada).

Amicus curiae National Association for Proton Therapy has filed a motion to associate attorney Agatha Marie Cole in this matter
