



12 Recommendation entered on 09/13/2022

13 On August 20<sup>th</sup>, 2022, Frederick O. Silver, filed DEFENDANT'S RULE 60(c) MOTION  
14 TO SET ASIDE DEFAULT AND DEFAULT JUDGMENT, AND WRIT PURSUANT THERETO  
15 AND DEFENDANT'S REQUEST FOR EVIDENTIARY HEARING AND/OR DISCOVERY RE  
16 SERVICE AND RULE 62 (b) MOTION TO STAY OF EXECUTION OF JUDGMENT PENDING  
17 HEARING.

18 Frederick O. Silver also challenged personal jurisdiction of the Clark County Court.

19 Frederick O. Silver never received a copy of Teuton, Sylvia, MASTER'S FINDINGS AND  
20 RECOMMENDATIONS but to any extend Frederick O. Silver files this objection so that this  
21 matter can be held by the Nevada Supreme Court.

22 Frederick O. Silver was never served with service of process in this Case and strict proof  
23 on the Record is demanded.

24 Frederick O. Silver never signed a birth certificate as to the Dead Bastard Child with  
25 Name: Gabriel William Towner.

Frederick O. Silver objects to the personal jurisdiction of the Clark County Court and  
never submitted to the Jurisdiction of the Court.

Frederick O. Silver never signed the voluntary acknowledgement of paternity as to the  
Dead Bastard Child with Name: Gabriel William Towner.

Frederick O. Silver has never been declared a vexatious litigant.

Frederick O. Silver does not owe Child support as to the Dead Bastard Child with Name:

12 *Demand is hereby made for the return of the Involuntary payment (\$1200) of May 6,*  
13 *2020 of the federal government covid 19 stimulus payment to FREDERICK OMOYUMA*  
14 *SILVER, Silver, Frederick Omoyuma, or Silver, Frederick O, which was intercepted by Clark*  
15 *County District Attorney and Office of the District Attorney Family Support Division 1900 East*

7 *The Fifth Amendment creates a number of rights relevant to both criminal and civil legal*  
8 *proceedings. In criminal cases, the Fifth Amendment guarantees the right to a grand jury,*  
9 *forbids “double jeopardy,” and protects against self-incrimination. It also requires that “due*  
10 *process of law” be part of any proceeding that denies a citizen “life, liberty or property” and*  
11 *requires the government to compensate citizens when it takes private property for public use.*

12 *The Sixth Amendment guarantees the rights of criminal defendants, including the right to*  
13 *a public trial without unnecessary delay, the right to a lawyer, the right to an impartial jury,*  
14 *and the right to know who your accusers are and the nature of the charges and evidence against*  
15 *you. It has been most visibly tested in a series of cases involving terrorism, but much more often*  
16 *figures in cases that involve (for example) jury selection or the protection of witnesses, including*  
17 *victims of sex crimes as well as witnesses in need of protection from retaliation.*

18 *The Seventh Amendmen Amendment VII*

19 *In suits at common law, where the value in controversy shall exceed twenty dollars, the*  
20 *right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise*  
21 *reexamined in any court of the United States, than according to the rules of the common law.*


22 *Neither slavery nor involuntary servitude, except as a punishment for crime whereof the*




