

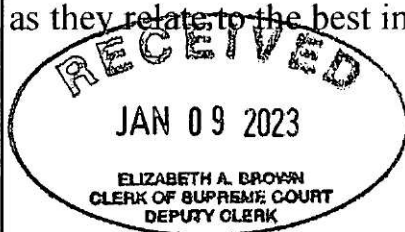
**MOTION REQUESTING LEAVE
