The following is the transcription of a tape-recorded interview conducted by DETECTIVE T. SANBORN, P#5450, LVMPD HOMICIDE SECTION, on August 21, 2019 at 1024 hours. Also present is DETECTIVE G. MAUCH, P#8566, LVMPD HOMICIDE SECTION.

Location is the Riverside County Jail. Present with me is my partner, Detective G. Mauch, M-A-U-C-H, P# 8566. And the subject we're interviewing is Tuly, T-U-L-Y, Lepolo, L-E-P-O-L-O, AKA Tutamua Lepolo, T-U-A-T-M-U-A, Lepolo. All right.

Q:	Hey, hey. How's it goin' Mr. Lepolo?
A:	How you doin'?
Q:	Good. You remember me?
A:	Yeah.

Q:	Yeah, yeah, yeah.
Q1:	Yeah.
Q:	It's been a couple years. Remember we went down to San Bernardino, got a
	DNA sample from you and whatnot? Um, so we got our DNA results back and I

	our DNA results back.

Q: This way we'll know. You have the right to remain silent. Anything you say can be used against you in a court of law. You have the right to consult with an attorney before questioning. You have the right to the presence of an attorney during questioning. If you cannot afford an attorney, one will be appointed before questioning. Do you understand?

Q: Okay. Cool. Okay so we - we came down here a couple years ago. We got your DNA. We compared that DNA, your DNA...

A: Mm-hm.

Q: ...to the, uh, blood evidence at our crime scene.

A: Mm-hm.

Q: And it was a match. So we now know that - I know you were there. I mean I - I don't want to play a whole lot of games with you. Um, I mean I know you were there at the time of the murder. So I just wanted to know what you - what you wanted to say about the - the evidence out there now. Like I don't know if you got hurt during the fight. Or if you got shot. I don't know if this other dude shot

- you. Or if he was shooting at someone else and hit you on accident. Like I'm just lookin' to find out what the fuck happened so I can find out who killed Raquel.
- A: Uh, like I said, you know, I don't know. Don't remember too much. I don't man
 I don't I don't even know if I was there. If the DNA puts me there then...
- Q: Yeah. We got a bunch of your blood there. I mean and and the description of where the pe- the witnesses said the shooter ran...

So I just didn't know why you - I didn't know if you got hit by - if he shot you. That's all.

A: So that links me to a possible shooter as well?

Q: Yeah. Yeah...

A: Okay.

Q: ...I mean right now - right now all the evidence - all the evidence suggests that you were the other person shooting.

A: Oh. Yeah.

Q: I mean that's kind of where we're at. If that's not the case, I mean I'd rather work

- Q: Why? Well who was shooting then?
- A: See I don't know. I don't know. You guys are pointing at the wrong direction. I mean I talked to you guys two years ago and the same results. It's like, you know, if I did get hit then if I di- if I - if I was bleeding then - then I'm just a victim. Right?
- Q: Possibly. Yeah.
- A: But I don't know who shot me or whoever - I don't know. I - be honest with you.
- Q: Yeah I mean possibly. If you ran off...
- A: There was a lot of people out there then, you know, well basically that's your witness saying that okay I might be the other guy or the one that got shot right?

- A: There go your witness right there. So and this is what - the time that, uh, it's time to get a lawyer.

But for some reason California, when they - probably when you gave a DNA sample for prison or whatever your, you know, they put it under Tuly. So when - when I got the hit back from the blood at my crime scene, it came back to Tuly Lepolo but with your FBI number.

A: That - that...

Q: So I mean it's the same - and then when I came in person to make sure, 'cause I don't want to...

A: I guarantee you that it did not hit under Tuly.

- Q: I oh man. I wish I would've brought the paperwork for you dude.
- A: Yeah anybody could do the paperwork and put...
- Q: No. That's how I otherwise I wouldn't even know who you were right? I would have no idea who you were.
- A: 'Cause if you knew who I were if if you if you came up with the FBI it would've came under my real name.
- Q: Well here's your FBI nu- here's your FBI right here.

- Q: Yeah. Well they're connected so I mean it doesn't really matter. Like to it's the same you're the same person. Like so, it and I've had it I I've had people hap- it happened before they're...
- A: And that warrant that you gave me for my blood test?
- Q: Yeah.
- A: For my DNA? That wasn't a good warrant. That had a dot on there.
- Q: A dot? What do you mean?
- A: It wasn't a good warrant. I remember I told you need a search warrant for my DNA.
- Q: We did get a search warrant.

Q: Well San Bernardino got that warrant for us based on our case so we - we provide them with the information on the case, they go to the judge in California. A: Mm-hm. Q: Get the warrant. That's why we came and saw you. But like I said, we came saw you, we took the DNA right from your mouth. A: Yeah... Q: Compared it right - right to the blood. And it's you. So, but you - I mean you can't offer me anything on what happened out there? A: Um, I mean you talked to the other witnesses. Like... Q: Mm-hm. A: ...uh, pretty much they're - they - I mean if they've given you descriptions of...

We talked to some folks but I'm talking to you right now. I mean you're the one
