UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF

Appellants/petitioners United Healthcare Insurance Company
("UHIC"), United Health Care Services Inc. ("UHS"), which does

business as UnitedHealthcare or “UHC” and through UHIC), UMR, Inc. (“UMR”), Sierra Health and Life Insurance Company (“SHL”), and Health Plan of Nevada, Inc., request a 90-day extension of time, through January 9, 2024, to file their reply brief. NRAP 31(b)(3). This is the first such request. The brief would otherwise be due October 11, 2023.

Good cause necessitates this extension. This is a complex case, raising novel issues. The record is expansive and requires diligent effort to distill the primary points into cohesive arguments without sacrificing necessary authorities. Both sides have been granted excess pages for their initial briefs. Respondents filed 13 additional appendix volumes to appellants’ 146 volumes. Appellants stipulated to a 90-day extension for respondents’ enlarged answering brief and request a similar extension for their reply.

Additionally, appellants’ counsel have been engulfed in preparing for three Supreme Court arguments, along with a fourth argument on dispositive motions in federal district court, among other pressing matters this month. The timing of respondent’s brief and those of amici also means that lead appellate counsel has been and will be unavailable

for much of time that would otherwise been devoted to preparing the reply, including long-planned out-of-state travel with family this past week and multiple meetings of professional associations throughout October.

Undersigned counsel has conferred with respondents/real parties in interest's counsel, Justin Fineberg, who does not oppose this motion.

The courtesy is appreciated.
