Pursuant to Nevada Supreme Court's Order ADKT No. 411, a person who is unable, without substantial hardship to himself or his dependents, to obtain competent qualified legal counsel on his own will be deemed indigent. Under this standard, a presumption of substantial hardship attaches to those persons currently serving a sentence in a correctional institution or housed in a mental health facility.

<sup>&</sup>lt;sup>1</sup> This Court's review of the file indicates that the Motion pertains to Mr. Voss' Petition for Writ of Habeas Corpus also filed May 22, 2019. This clarification is needed since on August 13, 2019 this Court issued an order granting Mr. Voss' Motion to Withdraw Court Appointed Trial Counsel (related to this Court's Order for Resentencing issued August 29, 2018).

Accordingly, and good cause appearing,

IT IS HEREBY ORDERED that the *Motion for Leave to Proceed in Forma Pauperis* is GRANTED.

IT IS HEREBY FURTHER ORDERED that the Court allow Steven Floyd Voss to bring such action without costs and file or issue any necessary writ, process pleading or paper without charge, with the exception of jury fees.

IT IS HEREBY FURTHER ORDERED that the Sheriff or any other appropriate officer within the state make personal service of any necessary writ, process, pleading or paper without charge for Steven Floyd Voss.

## <u>SENTENCING ON REMAND BY NEVADA S.C. - CONTD.</u>

Deputy D.A. Amos Stege represented the State.

Defendant present with John Petty, Esq.

Parole and Probation Specialist, Jenny Lopez, also present. Court referenced the Order by the Nevada Supreme Court to resentence the Defendant, but prior to the hearing date, the Defendant filed some appeals with the Nevada Supreme Court, so that would leave the jurisdiction of the case with the Nevada Supreme Court.

Counsel Petty agreed with the Court's assessment that she did not have jurisdiction in the case, although he believed she did have jurisdiction on deciding Defendant's Motion for Withdrawal of Court Appointed Attorney.

Counsel Stege spoke as to his concerns regarding the fugitive documents filed by the Defendant. He believed the only issue that may be addressed by the Court was the issue as to Defendant's counsel.

Court referenced a past District Court Order and indicated she would not go forward with the resentencing, however was inclined to hear argument on Defendant's Motion for Withdrawal of Court Appointed Attorney.

Counsel Stege deferred to the Court and to Counsel Petty regarding any future litigation on the issue.

Counsel Petty did not oppose the removal of the Public Defender's Office, however he did not agree with some of the Defendant's allegations within the motion. He requested the Court remove his office and appoint the Alternate Public Defender's Office.

Court questioned the Defendant directly regarding the situation; Defendant expressed his concerns with the conflict as to the Public Defender's Office.

Counsel Stege joined in the assessment of the claims with the Defendant's motion, he noted there was no finding as to ineffective assistance of counsel.

Court believed the Defendant's Motion for Withdrawal of Court Appointed Attorney was collateral to the case and accepted the representations of counsel regarding the conflict. She would not rule on the merits as to the performance of counsel, but solely base her decision on the conflict issue.

COURT granted Defendant's Motion for Withdrawal of Court Appointed Attorney, removed the Public Defender's Office and appointed the Alternate Public Defender's Office.

Court noted the Alternate Public Defender's Office would have significant time to meet with the Defendant, since the Defendant's appeals were pending with the Nevada Supreme Court. Counsel Stege addressed the issue of a new presentence investigation report (PSI), he believed it was collateral to the case. Court addressed the Nevada Supreme Court Order, her interpretation of said order was that the Court was to step into shoes of the sentencing Judge with the original PSI. Court indicated a supplemental PSI would not be ordered and the case would be treated as if it were 1996.

Deputy District Attorney Amos Stege was present in Court on behalf of the

State.

Deputy Alternate Public Defender Marc Picker was present in Court on behalf of Defendant Steven Floyd Voss, who was present, in custody of the

Nevada Department of Corrections.

Parole and Probation Specialist Michelle Wing was present in Court on behalf of the Department of Public Safety, Parole and Probation.

**COURT** reviewed the Motion to Dismiss the Alternate Public Defender's Office.

Counsel Picker addressed and advised the Court there is no conflict with the Alternate Public Defender's office representing the Defendant but that Defendant Voss wants to represent himself. Counsel Picker further advised that there is one remaining case at the Supreme Court, Case No. 77697, Appellant's Petition for Rehearing.

Defendant Voss addressed and advised the Court that he wants to represent himself at re-sentencing.

Counsel Picker argued that the Defendant meets the standard to represent himself and that he (Counsel Picker) supports the Defendant's request. Counsel Stege addressed the Court and argued the Court should make this finding.

**COURT FINDS** that Defendant Voss's request to represent himself is not pursuant to *Young v. State.* 

**COURT,** pursuant to Nevada Supreme Court Rule 253, canvassed the Defendant regarding his desire to represent himself, his understanding of the consequences of proceeding without counsel and of the dangers, disadvantages and consequences of self-representation.

Defendant Voss responded and stated that he feels he can best represent himself and that he has no issues with Counsel Picker and/or the Alternate Public Defender's Office.

**COURT FINDS** that Defendant Voss is competent to waive his constitutional right to be represented by an attorney.

**COURT ORDERED** Motion to Withdraw Court Appointed Counsel GRANTED. **COURT ORDERED** Defendant Voss is permitted to proceed as a self-represented litigant and the Alternate Public Defenders Office is relieved from representing Steven Voss.

COURT FURTHER ORDERED Defendant Voss has until close of business on August 30, 2019 to file a supplement to Counsel Picker's Response to the Motion for Updated PSI filed by the State of Nevada on May 21, 2019.

COURT FURTHER ORDERED State of Nevada has until close of business on September 13, 2019 to file a response to Defendant Voss' supplement and shall file a request for submission on the Motion for Updated PSI.

Defendant Voss requested a copy of the November 29, 2018 Transcript and indicated that he will have someone pick them up from the Court.

Court Reporter D. Cecere advised the Court that it typically takes between 7-15 days, once the request is received, to file the transcript.

#### **ENTRY OF JUDGMENT AND IMPOSITION OF SENTENCE**

Deputy District Attorney Amos Stege represented the State.

Defendant was present and in pro per.

Parole and Probation Specialist Jill Berryman was also present.

This hearing was held remotely because of the closure of the courthouse at 75 Court Street in Reno, Washoe County, Nevada due to the National and Local emergency caused by COVID-19. The Court and all the participants appeared via simultaneous audiovisual transmission. The Court was physically located in Reno, Washoe County, Nevada which was the site of the court session. Counsel acknowledged receipt of Notice that the hearing was taking place pursuant to Nevada Supreme Court Rules- Part 9 relating to simultaneous audiovisual transmissions and all counsel stated they had no objection to going forward in this manner.

Court noted the hearing was taking place via audiovisual means due to the closure of the courthouse. She questioned if all had received Notice and if there were any objections to proceeding; Counsel Stege indicated he received Notice and he had no objection to proceeding. Defendant Voss indicated he received Notice and objected to being resentenced via audiovisual means. He claimed it prevented him from presenting witnesses on his behalf.

Court addressed the pending motions filed by the Defendant and the decision by the Nevada Court of Appeals instructing the District Court to enter an Amended Judgment of Conviction. She presented the procedural history on the resentencing.

Court addressed each of the following motions individually and ruled:

- 1. Defendant's Motion to Rescind Order Staying Proceedings GRANTED
- 2. Defendant's Motion for New Trial and Defendant's Amended Motion for New Trial **BOTH DENIED**, **barred by statute**
- 3. Defendant's Presentencing Motions in Limine **DENIED**

Court addressed the Defendant's objection to resentencing via audiovisual means. She addressed both the Governor's order and the Administrative Orders that have led to the closure of the courthouse. She noted the Defendant's objection to resentencing via telephone also, so the hearing needed to take place via audiovisual means. She explained she was following each of the rules and procedures set forth by said Orders and Administrative Orders. The Defendant's objections are **denied** due to the pandemic.

4. Defendant's Motion for Return of Personal Property – **DENIED**Court was ready to proceed with resentencing.

Court questioned the Defendant if he had any corrections to the presentence investigation report (PSI); Defendant indicated there were many misrepresentations within the PSI.

Court and Defendant discussed the original change to the PSI regarding a case listed as a felony and changed to a misdemeanor.

Counsel Stege had no objection to the Court considering said case as a misdemeanor based on Counsel Conway's original objection, on the original sentencing date.

Defendant further addressed the bench warrants listed as active, he indicated the bench warrants had been recalled.

Court and Defendant addressed each of the active bench warrants individually.

Defendant further addressed the allegation within the PSI that referenced other arrests between a time period, he claimed no arrest on Possession of Controlled Substance. He indicated the Embezzlement was possibly resolved by a hearing and admitted to the Disorderly Conduct. He claimed his bother was found guilty of the charges and the charges against him were dropped. He addressed the probation revoked on page 3 of the PSI, he claimed it was diversion. He had no more issues with the PSI.

Counsel Stege objected to everything addressed by the Defendant with the exception of the previously mentioned misdemeanor that was addressed at the original sentencing. He argued the information contained within the PSI were facts as researched by the Division of Parole and Probation. He argued the Defendant was whitewashing his criminal history. He did not believe the history as stated would carry a lot of weight or not enough for the Court to change any of it.

Specialist Berryman had nothing to add.

Counsel Stege requested the Court take note of the Defendant's subsequent conviction for Murder and Kidnapping in CR97-2077.

Court stated she would not take the subsequent conviction into consideration, nor what Counsel Stege stated. She addressed the Order by the Court of Appeals. She directed the record reflect that page 5 of the PSI contained two paragraphs that would not be considered. She noted they started with "Upon" and "Furthermore". She addressed the last paragraph that started "As investigation" on page 6 of the PSI and indicated that would also not be considered. Further she noted the paragraph "During the" on page 7 of the PSI would not be considered, she would only consider the last portion.

Defendant made a statement and addressed Counsel Stege's comments.

Court addressed Counsel Stege's comment the Defendant's criminal history would not carry much weight as to judgment. She stated she would give the Defendant the benefit of the doubt as to the bench warrants they had previously discussed.

Defendant stated he had mitigating witnesses and it was impossible for him to have them testify via audiovisual means.

Court noted the Defendant's knowledge of the resentencing date, she further noted if the Defendant had subpoenaed his witnesses they would have been allowed to testify.

Defendant stated he was unaware he was able to file subpoenas.

Court directed the record reflect Northern Nevada Correctional Center was unable to accommodate the resentencing in May, but the State's application for setting and Order to Produce were both done well over 30 days in advance of the instant hearing. Counsel Stege continued to argue that the sentencing decision should take the Defendant's full criminal history into account. He requested the maximums on all counts and further requested they be served consecutively.

Defendant presented his sentencing argument. He addressed the original sentence by Judge Stone and the decision by the Nevada Supreme Court. He requested the sentences be considerably less than the original sentences.

Specialist Berryman indicated credit for time served was 7,205 days. She had nothing else to add.

**COURT RENDERED JUDGMENT as follows:** The Defendant having been found guilty by a Jury and no legal cause being shown as to why judgment should not be pronounced against him, the Court rendered judgment as follows: 1. That Steven Floyd Voss is guilty of the crime of Burglary, a violation of NRS 205.060, a category C felony, as charged in Count I of the Information. 2. That Steven Floyd Voss is guilty of the crime of Uttering a Forged Instrument, a violation of NRS 205.090 and NRS 205.110, a category D felony, as charged in Count II of the Information. 3. That Steven Floyd Voss is guilty of the crime of Uttering a Forged Instrument, a violation of NRS 205.090 and NRS 205.110, a category D felony, as charged in Count III of the Information. 4. That Steven Floyd Voss is guilty of the crime of Forgery, a violation of NRS 205.090, a category D felony, as charged in Count IV of the Information. 5. That Steven Floyd Voss is guilty of the crime of Forgery, a violation of NRS 205.090, a category D felony, as charged in Count V of the Information. 6. That Steven Floyd Voss is guilty of the crime of Attempted Theft, a violation of NRS 193.330 being an attempt to violate NRS 205.0832, a category D felony, as charged in Count VI of the Information. 7 That Steven Floyd Voss be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 12 months to a maximum term of 48 months, as to Count I. 8. That Steven Floyd Voss be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 12 months to a maximum term of 32 months, as to Count II, sentence to be served consecutively to the sentence imposed in Count I. 9. That Steven Floyd Voss be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 12 months to a maximum term of 32 months, as to Count IV, sentence to be served consecutively to the sentence imposed in Count II. 11. That Steven Floyd Voss be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 12 months to a maximum term of 32 months, as to Count V, sentence to be served concurrently with the sentence imposed in Count IV. 12. That Steven Floyd Voss be punished by imprisonment in the Nevada Department of Corrections for a minimum term of 12 months to a maximum term of 32 months, as to Count VI, sentence to be served consecutively to the sentence imposed in Count IV. 13. It is further ordered that the aggregate sentence imposed is a minimum of 48 months with a maximum of 144 months. Defendant shall receive credit for time served in the amount of 7,205 days. The Defendant is given credit for time already served, any excess that exceeds the Defendant's sentences shall be calculated and determined by the Nevada Department of Corrections.

14. It is further ordered that Steven Floyd Voss shall pay a \$25.00 administrative assessment fee and reimburse the County of Washoe the sum of \$750.00 for legal representation to the Clerk of the Second Judicial District Court. 15. Steven Floyd Voss is hereby advised that: Any fine, fee administrative assessment, or restitution imposed today (as reflected in this Judgment of Conviction) constitutes a lien, as defined in Nevada Revised Statute 176.275.
