AS ONE INMATE, HE CAN DO RESEARCH AND WOULD
BE ABLE TO REPLY TO PAROLE BOARD'S ANSWER.

THE PETITIONER WAS TRANSFERRED TO SEGREGATION ON DECEMBER 28, 2022 DUE TO PENDING INVESTIGATION TO A WRITE UP WITH FALSE CHARGE OF BATTERY. UPON TRANSFER, HE LOSE HIS ACCESS TO THE LAW LIBRARY AND OTHER LEVEL ONE PRIVILEGES. HIS PROPERTIES, INCLUDING HIS LEGAL NOTES AND DOCUMENTS, WERE CONFISCATED. THE PETITIONER SAW OTHERS GET THEIR PROPERTY BACK WITHIN A WEEK. THIS IS THE FIFTH WEEK FOR HIS STAY IN SEGREGATION AND YET HIS PROPERTY WAS NOT RETURNED. HE TRIED MULTIPLE REQUESTS BUT THEY DO NOT RESPOND. HE TRIED THE INFORMAL GRIEVANCE BUT STILL NO REPLY. HE TRIED GETTING EMERGENCY GRIEVANCE BUT IT IS NOT AVAILABLE. HE TRIED TO GET HELP FROM SERGEANTS BUT HE WAS TOLD TO WAIT FOR THE DISCIPLINARY HEARING. CASEWORKER SIBBER SAID I CAN TALK TO THEM ON JANUARY 27 DURING MY CLASSIFICATION REVIEW BUT EVEN THAT WAS CANCELED BY THEM.

DUE TO THE LIMITED TIME FRAME OF 14 DAYS TO REPLY TO THE PAROLE BOARD'S ANSWER OF WHICH WILL TAKE AT LEAST A WEEK BEFORE I GET THEM ON MY HAND FROM THE DAY THE PAROLE BOARD SENT IT OUT, I URGE THE COURT TO HELP ON THIS MATTER.

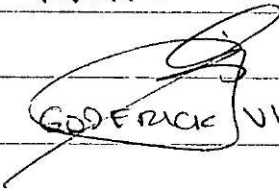
