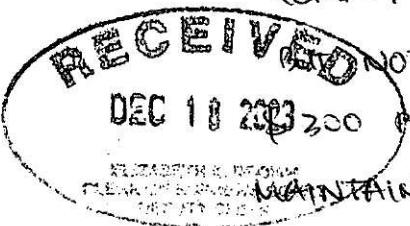

RELIEF SOUGHT

PETITIONER, GODERICK VILLADELGADO, MOVES THIS COURT
FOR AN ORDER:

1. REQUIRING THE BOARD OF PAROLE COMMISSIONERS
(BOARD) TO APPEAR BEFORE THIS COURT TO
ANSWER FOR THEIR CONTEMPT, AND
2. THAT AFTER HEARING, THE BOARD BE ADJUDGED
GUILTY OF CONTEMPT OF THIS COURT AND ORDERED:
 - a. TO PAY THE PETITIONER THE SUM OF \$600,000
AS DAMAGES OCCASSIONED BY THE CONTEMPT,
 - b. TO SUFFER WHATEVER SANCTION IS DEEMED BY
THE COURT SUFFICIENT TO COMPEL THE BOARD TO
COMPLY WITH THE COURT'S ORDERS [INCLUDING,
NOT LIMITED TO PAYMENT OF A FINE OF
\$300 PER DAY FOR EACH PETITIONER
MAINTAINED IN THE HIGH DESERT STATE

THE ORDER OF CIVIL CONTEMPT SOUGHT BY THIS
MOTION IS APPROPRIATE AND PROPER BECAUSE :

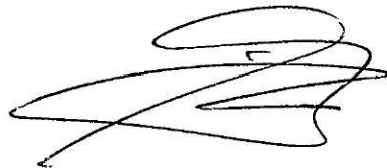
1. ON MAY 10, 2023, THIS COURT ENTERED AN
ORDER DIRECTED AT THE BOARD AND REQUIRING
IT TO :
 - a. VACATE THE APRIL 21, 2022 ORDER DENYING
PAROLE, AND
 - b. CONDUCT A NEW PAROLE HEARING IN WHICH
THE BOARD DOES NOT APPLY THE FACTORS
ENUMERATED IN NAC 213.518.
2. THE BOARD HAS FULL KNOWLEDGE OF THIS ORDER
AND AT ALL RELEVANT TIMES, HAD THE
ABILITY TO COMPLY WITH THE ORDER IN FULL.
3. DESPITE THE ORDER OF THIS COURT, THE BOARD
VIOLATED THE ORDER BY WAITING FOR MY NEXT
HEARING FOR MY MANDATORY PAROLE SO THE
BOARD DOES NOT HAVE TO DO THE ORDER.
