## DECLARATION OF ABRAHAM G. SMITH

- 1. I, Abraham G. Smith, make this declaration based upon my personal knowledge and information I believe to be true:
- 2. I am a partner at Lewis Roca Rothgerber Christie LLP and am licensed to practice law in the State of Nevada. I serve as appellate counsel of record for appellant A Cab Series LLC.
- 3. I came down with a serious strep infection the last two weeks in December.
- 4. My wife and children also had strep during that time, which required multiple visits to the emergency room, to urgent care, and to the pediatrician for myself and my children. I also had to care for my

children myself, even when ill, while my wife was severely ill and seeking treatment.

- 5. Jessica Helm, our extraordinarily diligent paralegal, was also very ill, through most of December.
- 6. Immediately after my return from out-of-state travel for the holidays, I again fell severely ill with what appears to be a strep reinfection.
- 7. I have mostly recovered with the help of a second round of antibiotics, but upon my return to work I have had to address an emergency hearing for preliminary injunction that—though I originally planned to assist for just one day—has now consumed that past three business days.
- 8. I have had almost no opportunity to work on this or my other cases since my return from my illness.
- 9. Another senior attorney on this matter is unexpectedly on a temporary leave of absence, beginning in January.
- 10. This leave was also entirely unforeseen and has greatly impacted the work for the remaining attorneys.

11. As a consequence, I and my colleagues worked diligently to prepare a draft brief and appendix. But we have not yet had time to finalize it.

I declare under penalty of perjury under the law of the State of Nevada that the foregoing is true and correct.
