**JOINT STIPULATION FOR EXTENSION OF TIME FOR
APPELLANT TO FILE HIS REPLY BRIEF**

This case is before this Court on an Order Accepting Certified Question and Directing Briefing. In its February 10, 2023 Order, this Court ordered Appellant's opening brief to be filed within 30 days, Respondent's answering brief due 30 days later, and a reply brief due 21 days after that. On March 1, 2023, Appellant sought and obtained a telephonic extension of time making his opening brief due March 27, 2023. Respondent's answering brief was due April 26, 2023, but Respondent sought and was granted a 60-day extension of time. Respondent filed its answering brief on June 26, 2023, making Appellant's reply brief due July 17, 2023.

Due to complexity of the issue presented, and the importance to the State of Nevada, its agricultural and ranching communities and the H2A workers they depend on, as well as the press of other professional commitments, Appellant asked Respondent to agree to a 28-day extension of time for filing Appellant's reply brief. Respondent agreed. Thus, the parties stipulate pursuant to NRAP 31(b)(2) to a 28-day extension, making Appellant's reply brief due August 14, 2023.
