Respondent-Legislators, Brittney Miller, Selena Torres, Dina Neal, and James Ohrenschall (collectively, “Legislators”), and Respondent The Legislature of the State of Nevada (“Legislature” and together with Legislators, “Respondents”), by and through their respective counsel of record, hereby move the Court for an additional thirty (30) days to file their respective answering briefs, which are presently due on **July 12, 2023**. If this motion were granted, the answering briefs would be due on **August 11, 2023**. This is the first request for enlargement of time.

Due to some upcoming, scheduled, pre-paid family vacation plans by some of Respondents’ counsel in this matter, Respondents request that this Court grant an extension until August 11, 2023, to file their respective answering brief.
