MEMORANDUM

I, TALEEN PANDUKHT, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office.

Respondent's Answering Brief is currently due June 29, 2023. This is an Appeal from the denial of a post-conviction Petition for Writ of Habeas Corpus. This Court may extend time to file a Respondent's Answering Brief upon a showing of good cause. NRAP 31(b)(3).

On May 30, 2023, Appellant filed an Opening Brief from the Denial of a Post-Conviction Petition for Habeas Corpus that the district court determined was procedurally barred. Appellant's Opening Brief challenges numerous issues, and Appellant has had substantial time to identify and brief the substantive legal issues in the instant appeal. Appellant included a four (4) volume joint appendix consisting of 800 pages.
