MOTION TO INTERVENE" ON 3/2/22

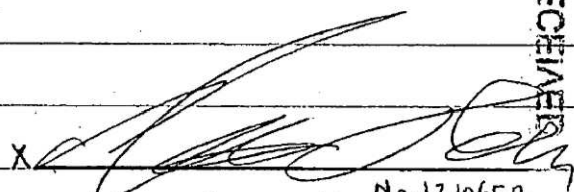

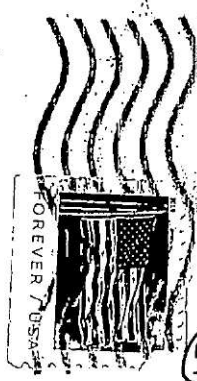

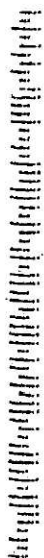
