## POINTS AND AUTHORITIES

For the reasons stated in the attached Declaration of Counsel, and pursuant to Nevada Rules of Appellate Procedure 26, 27, and 31(b)(3), James Hayes requests an extension of thirty-two (32) days in which to file his Opening Brief, from June 15, 2023, up to and including July 17, 2023.

### **DECLARATION OF COUNSEL**

- I, Martin L. Novillo, do declare as follows:
- I am counsel for the Appellant in the above-entitled matter.
   I have personal knowledge of the matters contained herein and am competent to testify thereto.
  - 2. Appellant's Opening Brief is currently due June 15, 2023.
- 3. No extensions have previously been sought or granted with respect to the Opening Brief.
- 4. An extension of time is necessary on account of various filing deadlines and court dates, which declarant has had to recently meet. Specifically, on April 17, 2023, declarant had to finalize and file an amended petition in the non-capital habeas matter of *Villa v*. *Hutchings, et al.*, 21-cv-02030-ART (D. Nev.). In addition, declarant had to draft and, on May 10, 2023, file an opposition to a motion in limine in the federal trial matter, *United States v. Schlesinger*, 18-cr-02719-RCC (D. Ariz.).
