**UNOPPOSED MOTION FOR EXTENSION OF TIME  
TO FILE OPENING BRIEF AND APPENDIX**

Appellants request an extension through January 26, 2024 to file their opening brief. The opening brief was due October 24, 2023, which the parties stipulated to extend by 30 days to November 27, 2023. That stipulation has not yet been granted by the Court. Also pending is respondent Get Fresh Sales, Inc.'s renewed motion to dismiss the appeal.

There is good cause to extend the deadline, and respondents do not oppose this request. The extension will provide additional time before the opening brief is due for the Court to provide guidance on the renewed motion to dismiss. In addition to the uncertainty of the outcome on the motion to dismiss the appeal, undersigned counsel and the other attorney responsible for the brief have been dealing with personal matters and

family obligations that are delaying preparation of the brief, including unanticipated difficulties in moving to a new house and attending several doctor appointments with family members. Both attorneys also traveled out of town to visit family for the Thanksgiving holiday. These personal obligations have caused delays separate from other delays caused by counsel tending to unexpected motion practice in various trial-level cases.

Appellants seek a 60-day extension for all of the above reasons, but also because a 30-day extension would place the new deadline during the Christmas and New Year holidays. Appellants appreciate respondents' courtesy in not opposing this request.
