IDENTIFYING MARKS: The left ear is pierced once. The number "5" is tattooed to the right arm. An illegible tattoo is on the back of the right thumb $(3/4 \times 1/2\text{-inch})$. A letter "M" is tattooed to the left arm. An illegible tattoo is on the left "snuff box" $(3/4 \times 3/4 \text{ inch})$. Multiple small scars are on the lower extremities bilaterally, none greater than 2 inches.

X-RAYS: X-ray film of the skull and upper aspect of the torso reveals no projectiles within any of the areas x-rayed. There are apparent bone chips in the left lateral aspect of the calvarium. A fracture is noted within the right temporal region of the calvarium.

EVIDENCE OF MEDICAL INTERVENTION: None.

EVIDENCE OF INJURY:

<u>Head</u>: A road-rash type abrasion is on the left aspect of the forehead just above the eyebrow $(3 \times 3 \text{ inches})$. A road-rash type abrasion and laceration is on the bridge of the nose $(2 \times 1 \text{ inch})$. A road-rash abrasion combination laceration with embedded stones is on the corner of the left eye $(1/2 \times 1/2 \text{ inches})$.

A 1 x 1 inch contusion/abrasion is on the left inner aspect of the lower lip. A 1/2 x 1/2-inch similar contusion/abrasion is on the left aspect of the inner aspect of the upper lip. A 3/4 x 1/4 inch laceration with skin tags is on the left side of the upper lip just above the nose.

Left Forearm and Hand: Blood is on the left forearm and hand, as well as small abrasions, none greater than 1/2 inch.

Right Hand: Drying blood is on the back of the right hand as well as 2 small abrasions on the back of the right wrist averaging 1/8 inch each.

<u>Legs</u>: Drying scabbed abrasions are on the right patella and leg averaging 1/4 inch each. Drying abrasions are on the left knee $(1/2 \times 1/2 \text{ inches in toto})$.

Perforating gunshot wound of head.

Entrance: Situated on the posterior aspect of the left ear 4-3/4 inches below the top of the head is a stellate defect (1/4 inch with partial marginal abrasion, consistent with gunshot wound of entry and immediate exit from the posterior aspect of the ear.

Re-entry: Situated directly behind the left ear is a $1/4 \times 1/8$ -inch stellate laceration with large circumferential marginal abrasion measuring 1/4 inch in greatest width. There is no soot, burned or unburned gunpowder particles on the skin surrounding the wound.

Path: Skin, skull, brain, skull and skin.

The hemorrhagic wound tract traverses the left temporal cerebral lobe with destruction of all vessels and nerves at the base of the brain, in particular the circle of Willis and the optic chiasm. The hemorrhagic wound tract continues to the right frontal lobe. There are associated multiple fractures of both orbital plates and the cribriform plate. Multiple fractures radiate from the entrance defect. Also associated is subdural hemorrhage surrounding the brain stem and cerebellum and subarachnoid hemorrhage over the majority of the brain surface.

 $\underline{\text{Exit}}$: Situated on the right temple 4-1/2 inches from the top of the head and 3 inches right of the midline is a relatively round gunshot wound of exit with radiating stellate lacerations. The underlying bone is beveled outward. There is partial evulsion of bone chips.

Trajectory: The decedent's left to right, back to front with no significant upward or downward deviation.

INTERNAL EXAMINATION: The body is opened in the usual manner with a Y-shaped incision revealing a normal arrangement of internal organs. There are no adhesions or abnormal fluid collections in the body cavities.

CARDIOVASCULAR SYSTEM: The pericardial surfaces of the 290-gram heart are smooth, glistening and unremarkable. The pericardial sac is free of significant fluid or adhesions. The coronary arteries arise normally and follow the usual distribution of a right dominant pattern with no significant atherosclerotic The chambers and valves bear the usual size and stenoses. position relationship and are unremarkable. The right ventricular wall is 0.3 and the left 1.3 centimeters in thickness. The myocardium is dark red-brown, firm and unremarkable; the atrial and ventricular septa are intact. The aorta and its major branches arise normally and follow the usual course with no significant atherosclerosis. The vena cava and its major tributaries return to the heart in the usual distribution and are unremarkable.

RESPIRATORY SYSTEM: The right and left lungs are 1120 grams, together. The upper and lower airways are patent and the mucosal surfaces are smooth, yellow-tan and unremarkable. The pleural surfaces are smooth, glistening and unremarkable. The pulmonary parenchyma is dark red-purple and exudes abundant amounts of blood and frothy fluid. The pulmonary arteries are normally developed and patent.

DIGESTIVE/HEPATOBILIARY SYSTEM: The esophagus is lined by gray-white smooth mucosa. The gastric mucosa is arranged in the usual rugal folds, and the lumen contains 350 milliliters of thick tan fluid admixed with partially digested food particles. The small and large intestines are unremarkable. The mesentery and omentum appear normal, and the vessels are patent. The appendix is present. The colon contains formed stool. The pancreas has a normal gray-white lobulated appearance, and the ducts are clear. The liver is 1500 grams. The hepatic capsule is smooth, glistening and intact, covering red-brown parenchyma. The gallbladder contains viscid bile. The extrahepatic biliary tree is patent.

ENDOCRINE SYSTEM: The pituitary, thyroid and adrenal glands are unremarkable. Distinct parathyroid glands are not seen.

GENITOURINARY SYSTEM: The normal shaped kidneys are 210 grams together. The renal capsules are smooth, thin, semitransparent, and strip with ease from the underlying, smooth, red-brown, firm, cortical surfaces. The cortices are sharply delineated from the medullary pyramids. The calyces, pelves and ureters are unremarkable. The urinary bladder is empty; the mucosa is graytan and smooth. The testes are unremarkable. The prostate is not examined.

HEMATOPOIETIC SYSTEM: The thymus is dispersed in anterior mediastinal fat. The spleen is 70 grams and has a smooth intact capsule covering red-brown moderately firm parenchyma. The regional lymph nodes appear normal. The bone marrow is red-purple and homogeneous, without evidence of focal abnormality.

MUSCULOSKELETAL SYSTEM: Aside from the injuries previously described, the bony framework, supporting musculature and soft tissues are not unusual.

NECK: Examination of the soft tissues of the neck, including strap muscles and large vessels, reveals no abnormalities. The hyoid bone and larynx are intact. The tongue is normal.

NERVOUS SYSTEM: The brain is 1340 grams and has a trauma previously described. No other abnormalities are noted. The spinal cord is not examined.

SPECIMENS OBTAINED: Blood for standard toxicology. Vitreous for storage. Kidney and rib to Crime Scene Analyst. Tissue to stock.

SUMMARY OF INVESTIGATION

On 07/22/00 at 0445 hours, I responded to the alley area behind the apartment building at 2933 Elm Avenue, in Las Vegas, on a report from the Las Vegas Metropolitan Police Department (LVMPD) of an apparent homicide.

Upon arrival at approximately 0505 hours, LVMPD Homicide Detective M. McNett, who related the following information, met me. The decedent was a 20 year-old Spanish male who was drinking with male friends in this area this morning. At approximately 0130 hours, the men were approached by one of the residents who lived in the apartment building who complained about the disturbance they were causing in the alley. A verbal and possibly a physical altercation broke loose and the decedent was shot in the head with possibly a .45 caliber handgun. He informed me that there were 10 spent .45 caliber casings found at the scene. Reference LVMPD Event #000722-0165.

I viewed a Spanish male lying supine on the asphalt covered alley/parking lot, approximately 30 feet north of the apartment building at 2933 Elm Avenue. The decedent was directly behind an older model Ford pickup that was parked next to the building. The decedent's head was to the west and feet to the east. Both legs were straight with the right leg crossed over the left leg at the ankle. The left arm was straight and down to his side. The right arm was straight and perpendicular with the body. He was clothed in a white shirt, blue shorts, white socks, green, and white athletic shoes. I observed a large amount of apparent blood trailing north down the alley from the decedent's head.

Upon examination of the decedent's body, I found the skin cool to the touch with blanching posterior lividity that was consistent with his position. Rigor mortis was present in the neck and jaw. A large amount of apparent dried blood was noted on the decedent's face that was emanating from the nose, mouth and forehead and trailing down both sides of the head. I observed what appeared to be a penetrating defect in the forehead. The head and scalp were not palpated in order to preserve any trace evidence. I observed minor abrasions on both knees. I found no signs of life and pronounced death at 0515 hours.

I spoke with the decedent's brother, Leonardo Martinez, who was at the scene. He informed me that the decedent had never been married and that he did not have any children. He stated that the decedent's parents lived in Mexico. He advised me that he would contact them and advise them of the decedent's demise. He stated he would contact the Clark County Coroner/Medical Examiner's Office (CCCME) when he made contact with them.

The decedent was wrapped in a new sheet and was placed in a new body bag. The bag was sealed with Coroner Seal #349949. Desert Mortuary transported the decedent from the scene to CCCME. We departed the scene at 0550 hours, and arrived at CCCME at 0605 hours, per protocol.

Detective McNett requested that all property to be left on the decedent in order to preserve any trace evidence. I observed a neck chain around the decedent's neck.

Property Receipt #64763 indicates that all property was left on the decedent. Reference Coroner Seal #349949.
