**MOTION TO EXTEND TIME TO  
FILE TRANSCRIPT REQUEST  
FORM OR CERTIFICATE  
REGARDING TRANSCRIPTS OF  
PROCEEDINGS  
(FIRST REQUEST)**

8           Appellant Michael Tricarichi (“Appellant”), by and through his undersigned  
9           counsel of record, hereby moves this Court to extend the time to file his transcript  
10          request form or certificate confirming no need to order transcripts (“Certificate”)  
11          by seven (7) days, to be due on or before July 12, 2023. This is Appellant’s first  
12          request for an extension.

13          On June 27, 2023, this Court filed an Order which required Appellant to,  
14          among other things, file his transcript request form or Certificate by July 5, 2023.  
15          Unfortunately, due to an unforeseen technological glitch in Hutchison & Steffen,  
16          PLLC’s email system—Appellant’s local counsel’s office—Appellant did not  
17          receive electronic notice of the Court’s Order until after the deadline had passed.<sup>1</sup>  
18          Similarly, Appellant’s lead counsel, Sperling & Slater, P.C., likewise has been

1 unable to locate a copy of the Court’s order (electronic or otherwise). As a result  
2 of this technological mishap, the deadline to submit the transcript form or  
3 Certificate was not calendared, and Appellant did not timely file it.

4 Notably, Appellant already has—and therefore does not need to request—all  
5 necessary transcripts related to the issues on appeal in this case. He intends to  
6 produce all necessary transcripts at the time of filing his opening brief. For the  
7 convenience of the Court, Appellant’s Certificate, which is filed concurrently  
8 herewith, is attached hereto as Exhibit 1.
