1 Α Yes. And what were you doing at the time around 5:30, 2 3 6:00 p.m.? 4 Doing reports. Α 5 Is that part of your job? Q 6 Yes. Α 7 Paperwork? Q 8 Α Yes. 9 All right. Α Did you ask for his driver's license? 9 Q 10 I believe I did. Α Did you ask him what was going on, why he was there? 11 Q 12 Yes, I did. Α And what specifically did he tell you? 13 Q He told me that earlier that morning he had shot his 14 estranged wife and her boyfriend. 15 16 In Las Vegas? Q 17 Correct. Α At that point after hearing that did you place him 18 19 in handcuffs? 20 I did. Α That's for your own safety as well for the safety of 21 the other officers in that facility that you were located at? 23 Yes, everyone's safety. 24 Did Mr. White ever mention to you a vehicle that he Q 25 had traveled in to Yavapai County?

Yes, he did. 1 Α 2 And what kind of vehicle did he identify? Q It was either a gray or a silver 2008 Dodge Durango. 3 Α Did he mention whether there were any weapons inside 4 5 of that vehicle? 6 Yes, he did. Α 7 What did he tell you? 8 Said that there was a pistol in the spare tire Α compartment in the car. 9 10 Did you ask him whether that pistol was the one that Q he had used in the shooting that morning? 11 12 I did. Α And what did he tell you? 13 Q He said, it was. 14 Did you ever proceed to that vehicle outside of the 15 Q facility you were at? 16 Yes, I did. 17 Α Did you have a good look at it? 18 Q 19 Reasonably good, yes. Α Do you think you'd remember it if I showed you a 20 Q picture of it? 21 22 Yes. Α 23 All right. Showing you State's Exhibit Number 65. 24 That's a Dodge Durango. I would know it if I saw Α 25 the license plate.

Q Okay. Let me get that. I'm showing you State's 1 2 Exhibit Number 66. Yes, that's the vehicle. You can recognize it now because of the license 4 5 plate? 6 I remember the license plate because it said, Α Yes. 7 USN, and I associated that with the United States Navy. 8 Okay. But really it also says us and pretty boys? Q 9 Well, that's a way to look at it, too. Okay. This is a rear view of that same vehicle, 10 Q 11 sir? 12 Α Yes. Were you one of the first people he had contact with 0 10 or did he have contact with other officers first? 11 I believe I was the third person. I believe he had Α 12 had contact with Deputies Jaeger and Bray before me, because they were the ones that contacted me. 13 Small community, you know each other? 14 15 Fairly. Α Know by site anyway. You may not go to each other's 16 house every weekend, but you know who Jaeger is? 17 18 Α Yes. 19 And he's the gentleman that just left our courtroom a few moments ago; yes? 20 21 Α Yeah. Now, there was some discussion about this word 22 "estranged." Do you remember that --23 24 Yeah. Α -- a moment ago? Okay. And this has been over two 25

years at this point, almost three? 1 Almost three, yes, sir. You did a declaration for a search warrant in this 4 case; yes? 5 Α Yes. And a declaration for a search warrant is something 6 0 that you fill out so you can look through people's property? 7 8 Correct. It's a statement for the judge. Α Statement for the judge? 0 10 Yeah. Α 11 You can't, on your own, just go search things 12 without a search warrant in general, or there might be problems later because we have certain privacy rights; is that 13 14 fair? 15 That's fair. Α The Constitution says the government can't come into 16 your house and riffle through your stuff without a search 17 So you fill out an affidavit for a search warrant? 18 warrant. 19 Correct. Α And in that affidavit for a search warrant you make 20 0 this one statement; yeah? 21 22 Yeah. Α 23 It is important to be fair; yeah? 24 Α Yeah. 25 It's important to be accurate?

Yeah. 1 Α It's important to be complete? 2 Q 3 Yeah. Α 1 I was. And is that area command patrol or cover the area of 2 Altamira Road, which is just north of Alta? 3 4 That is correct. Α 5 On July 27th, 2012, were you dispatched to 325 Q 6 Altamira Road in reference to a shooting that occurred there? 7 Α I was. Were there other officers who were also dispatched 8 9 to that home, as well? 10 Α Yes. 11 And do you remember who they were? I remember a couple. It was Officer Matt O'Brian, 12 Α 13 Officer David Horowitz and Officer Michelle Casper. Were you one of the first officers to arrive on the 14 15 scene? 16 I think I was number three or four. Do you recall -- showing you Exhibit 27, do you 17 Q recall this being the residence located at 325 Altamira? 18 19 Α Yes. And at the time you arrived, clearly that crime 20 scene tape was not present. That's something that was put up 21 by you or other patrol officers later on; right? 23 That is correct. What's the first thing that you did when you arrived 24 Q at 325 Altamira? 25

A I came south in front of the house where those two windows are, I can't really point, and then I approached up the driveway to go to the front door. There was some kids out in the driveway that I saw immediately. I think there was a uniformed officer, too, out in the driveway. As I approached I could see — got up to the front door, the front door was open. You could see more kids inside now of the residence. So there's kids out in the driveway, there's kids inside the residence. The kids looked extremely excited. I think some were crying. I believe at that time I had directed Officer Michelle Casper gather up all the kids and take the kids to a neighbor's residence.

- Q Now, sir, at this time the only information that you know about what occurred at 325 Altamira is through your radio communications; correct?
 - A That is true.

- Q And what is the information that you had at the time that you came upon 325 Altamira?
- A Initially it was a young boy had gone to a neighbor's house and told the neighbor that his father had shot his mother. So a neighbor had called our communications, and it goes from the call taker to the dispatcher to us. So it was the call taker, the dispatcher, then to us, and then we were dispatched.
- 25 Q So at the time that you arrive in the house did you

have any idea whether the potential shooter was still present?

A Yeah. Because the information, as it comes in, it's not given to you all at one shot. It usually comes in pieces, and usually the pieces are behind the curve. So the information was being updated as officers are still going there. And the updated information was, there was two victims, possibly one of the victims is a friend. The dispatcher was able to pull I believe prior events -- prior event --

Q Okay. Stop right there. Let me just ask you this. At the time did you know whether the shooter was still at that house?

A Trying to remember going further, continuing on -- to address that question --

Q Well, let me ask you a different question. You're a police officer, you come upon a house that apparently a shooting had just taken place, for officer safety what is it that you do when you first get there?

A Okay. I see where you're going with this. The information, all we knew is that two people had been shot. Didn't know if the person who did the shooting was still at the scene. So I probably -- he was still there. There was no information that he had left. Does that answer it?

Q All right. So did you enter the house and do what's called clearing the house?

- 1 A Absolutely, yes.
 - Q And what is that?
 - A When we first get to there we -- we believe we had at least two victims for sure, a possible shooting suspect who is -- high probability still at the scene, no information that he left. First duty is to make the scene safe, and that is to go in and clear that for any potential suspects. And that was the first and primary, and that's what we did.

- Q And that's approximately what you saw when you came in; is that fair?
 - A I would say yeah. I didn't -- when I came in I did one of those shots to the right, because somebody had already cleared that area. So I didn't pay too much attention, I went down the hallway and went that way.
- Q And this may be looking the other direction than you came in from actually; right? You might --

When you come in you can either look right or left. Α 1 So my focus, my jury time was to the left down the hallway. 2 3 Okay. The ER had not arrived; yeah? Q 4 No. Α 5 You did speak to somebody who identified themselves Q 6 as Mr. Averman? 7 Α Yes. And Averman had told you that the female, her 8 Q 9 husband had been the one that had done the shooting? 10 Α Yes. And the Durango, was it a Dodge Durango? 11 12 Α Yes. The Dodge Durango you said was shared. 13 Q Just so we're clear, it was shared between the husband and the wife, 14 not Averman and the wife; is that right? 15 16 Α That's correct. Okay. And there was a question, you gave a 17 Q voluntary statement, it was on tape? 18 19 Α Yes. And you were asked whether you had moved anything 20 Q purposely other than, for example, the child? 21 22 Α Yes. 23 And you said, I didn't touch or move anything else in the residence; is that right? 24 25 Well, that's not right. That's not truly accurate

in the statement.

Q Okay.

A When we had the infant I picked up the baby bag in the crib, and I go uh-o, and I put the baby bag back in the crib. Anything -- I didn't touch anything else in the residence.

Q Okay. But that's a good example of how particular you are with moving things, because you don't know what's important at a crime scene?

A Well, at that time, I'll be honest with you, with the baby, picking up the baby, I'm like this has got to go. Then I realize it's got to stay. So --

Q Understood. And that was because of a concern of preserving evidence?

A The baby. Well, I picked up the bag for the baby during the -- of now the victims -- I was getting the baby out. It was a baby bag in the crib, not really thinking, here's a baby -- obviously the baby's like really small, this has got to go with the baby, because the baby's going to need this and go, I think it's got to stay. Put the baby bag back.

Q Did you see any vehicles coming or going as you approached the --

A No, I did not.

Q -- residence? Is that something you would watch for?

Oh, yeah. 1 Α Thank you for coming in for us, Officer. 2 Q 3 THE COURT: Any redirect? MR. ROGAN: 4 Yes. 5 REDIRECT EXAMINATION 6 BY MR. ROGAN: Officer, I think the point that Mr. Coffee and I are 7 both trying to make, just so we're 100 percent clear, is 8 9 things can get moved around at a crime scene that is, as you described, dynamic --10 11 Yes. A We received our initial briefing from the detectives who had responded prior to the homicide section. And then after that briefing we then interviewed all of the first arriving officers.

Q If fact, sir, isn't it that you actually arrived at about 1:45 p.m., because those other detectives had been called out before?

A That's correct.

Q All right. Because your whole detective squad actually arrived at scene do you split up the duties for your investigation?

A Yes.

Q Is it fair to say that some people conduct witness interviews?

A Correct. The majority of the detectives conduct the witness interviews as well as the canvas of the neighborhood.

Q Okay.

A And then my partner or I would take the responsibility of documenting the crime scene along with crime scene analysts.

Q I see. Who was your partner at the time?

Detective Travis Ivy. 1 Α 2 So did you and Detective Ivy conduct an examination 3 of 325 Altamira? Α Yes. 5 And some other detectives split up the duties of Q talking to various witnesses? 6 7 Α Correct. And some of those witnesses included Robert Wilson, 8 , Herman Allen. Those are names of people that 9 were interviewed during the course of your investigation? 10 11 Yes. Α 12 Just some of them? 0 13 Α Yes. Okay. Do you remember when you arrived on scene, 14 showing you State's Exhibit 27, was this the condition of 325 15 Altamira when you arrived? 16 17 Α Yes. And you noticed that there is a white vehicle parked 18 in front of the garage? 19 20 Α Yes. And did you or another officer, and I know you can't 21 see the license plate, run the registration of that vehicle? 23 Yes, we did. 24 Do you recall now who that vehicle was registered Q 25 to?

It was a Ford Escort, and it returned a Nevada DMV Α 1 to Joseph Averman. 2 Okay. Was there anything else of evidentiary value 3 Q that you noticed in that driveway or that was pointed out to you as having evidentiary value? 5 6 Yes. Α 7 What was that? 0 8 There was a backpack that was left in the driveway Α here. And inside of the backpack there was an empty gun 10 holster. 11 Showing you State's Exhibit 24. Is that the empty Q 12 gun holster you've just described? 13 Α Yes. And there was also just some loose change inside 14 that backpack; correct? 15 16 Correct. Α And that's essentially the extent of the contents of 17 that backpack? 18 19 Α Yes. And why was that holster important to your 20 investigation? 21 22 Because at this point we believe we were looking for Α 23 an outstanding firearm. 24 Did you actually find a firearm at the scene? Q 25 Α No.

Did you go inside that house at 325 Altamira? 1 Q 2 Α Yes. And the two victims that you learned had been shot 3 Q 4 were already -- had been removed and attended to by 5 paramedics? 6 Α Correct. 7 And they'd already left the scene? Q 8 Correct. Α All right. So when you went in what was your goal? 10 To gather as much evidence as we could to help Α 11 determine what took place inside the house prior to our 12 arrival. Okay. And you were accompanied by a crime scene 13 Q analyst by the name of Tracy Branley now known as Tracy Kruse? 14 15 Correct. Α Okay. Did you observe the living room area as 16 depicted in Exhibit 39? 17 18 Α Yes. Q All right. These photographs on the wall as 1 2 depicted in Defendant's Exhibit A and B, unremarkable; 3 correct? 4 Correct. Α 5 Not important to your investigation? Q 6 Other than to establish the relationships. 7 Okay. At some point you went into a room that I Q believe you and the other detectives began identifying as the 9 craft room? 10 Α Correct. And this was located down the end of the hallway on 11 0 12 the right-hand side? 13 Yes. Α And you went in there with CSA Branley or CSA Kruse? 14 Q 15 Correct. Α And what, if anything, did you notice on the ground 16 there that was important to your investigation? 17 18 In the craft room I believe we located articles of Α 19 clothing, which should have been removed during life saving efforts by paramedics. There was also a cellular telephone I 20 believe -- actually, I believe there were multiple cellular 21 telephones recovered from that room. Okay. Showing you State's Exhibit 47. Does this 23 24 appear to be a shot of that craft room from the hallway?

And those are depicted in there with the evidence 1 Q 2 marker 7 through 11. Those are the clothing that were removed 3 by paramedics before you arrived? 4 Correct. Α 5 State's Exhibit Number 52. Why was that important 0 6 to your investigation? 7 This here was the shirt that appeared to be removed from Ms. White or Lucas, and it's important to the investigation because of the defects or holes that would be in 10 it. And you can -- was this apparent to you that it had 11 12 been removed from her body by being cut off? 13 Yes. Α And you can see up here that the bands on the 14 shoulders, where it has been cut? 15 16 Α Yes. Okay. You also mentioned that there was a number of 17 Q cell phones. Do you remember how many cell phones were 18 19 recovered throughout the house? 20 Α Throughout the house or just the craft room? 21 Just the craft room. Let's start there. 22 I believe in the craft room there were two. 23 So there were several cell phones that were recovered throughout the house though? 24 25 I also remember seeing additional cell phones in the

room directly across the hall, as well. 1 2 State's Exhibit 54 though, what is depicted in that? That's a cell phone, a white Apple iPhone that was Α recovered from the craft room. 4 5 Now, did that to you end up being the only cell Q 6 phone of evidentiary value in the course of your 7 investigation? Primarily, yes. 8 Α 9 Q Did you determine whose cell phone that was? 10 This phone belonged to the victim, Echo. Α 11 Echo Lucas? Q 12 Lucas, yes. Α 13 Also known as Echo White? Q 14 Correct. Α All right. Did you cease that cell phone and 15 Q impound it as evidence? 16 17 Α Yes. And subsequent to your examination of the house and 18 whatever else you did that day, which we'll get into, did you 19 20 ask for that phone to be forensically examined by a division 21 of the Las Vegas Metropolitan Police Department? Yes, I did. 22 Α 23 And the purpose of that was to determine the contents of that phone? 24 25 Correct.

And you took a look inside that master bedroom 6 Q 7 during the course of your investigation? 8 Α Yes. Showing you State's Exhibit 55. What do we see 0 10 here? 11 That's looking from the hallway almost directly Α 12 south right into the master bedroom. You see the baby crib there, and a broken mirror beyond that. You can't really tell 13 in this picture, but there's a bullet hole in the wall that 14 exited out the south side of the house out toward the driveway 15 16 area. Also, while you were in there did you observe the 17 Q area directly in front of the dresser depicted in 58? 18 19 Α Yes. And do you see the blood there depicted in front of 20 0 21 that dresser? 22 Yes. Α 23 And was that identified to you as the location where 24 Joseph Averman, the other victim, had been laying? 25 Yes. Α

At the time that you made entry did you see what's Q 1 depicted in State's Exhibit 59? 2 3 Α Yes. 4 And was does that appear to you to be? 5 I believe it was a shirt that was removed from Mr. Α 6 Averman by paramedics prior to our arrival. 7 And was that ceased as evidence? 0 8 Α Yes. And after it was ceased as evidence was it 0 10 photographed? 11 Α Yes. Showing you State's Exhibit 60. Is this a 12 Q photograph that was taken by crime scene analysts depicting 13 that shirt I guess as it should look? 14 15 Yes. Α 16 And it's covered in blood, is it not? Yes, it is. 17 Α 18 As the other detectives in your squad were conducting interviews of the witnesses that we briefly 19 20 mentioned did they update you with the information that they were learning? 21 22 Yes. - Q And did you learn the relationship between Troy White and Echo Lucas?
 - A Troy White was the estranged husband of the victim.
- Q Did you learn whether Troy White was living there on a full-time basis at 325 Altamira?
- A I learned that he was not living there on a fulltime basis. He would stay there on the weekends only.
- Q And so you knew at this point that Troy White presumably had a firearm that he used to shoot Echo White and Joseph Averman; correct?
- 13 A Yes.
 - Q Did you subsequently conduct an investigation to determine whether Troy White had what's known as a carrying a concealed weapon permit?

 - Q And what is a carrying a concealed weapon permit?

- Q And where did you learn that he had turned himself in?
- A The call came through our dispatch from Prescott,

 Arizona, that was the location where he had turned himself in

 at.
 - Q Did you at some point drive down to Prescott, Arizona?
 - A Correct. A little bit after receiving the information that he was there, then my partner and I along with a crime scene analyst responded to that location.
- 12 Q How long did it take you to get there?
- 13 A It's somewhere around the four hour range I would 14 guess.
 - Q And during the course of your investigation did you learn that Troy White and Echo White had been members of a religious sect called The Potter's House?
- 18 A Yes.
- Q And does Prescott, Arizona have any significance for that religious group?
 - A It ended -- yes, it did have significance. I believe it was -- The Potter's House Church was founded there by, and I can't remember the gentleman's name, but that was the founding location of that church. And I believe it occurred in the '70s, maybe 1970.

Q And did you also subsequently delve into the religious beliefs of The Potter's House?

A Yes, because I wanted to learn if there was any importance to turning yourself in in Prescott, Arizona versus Las Vegas. So that's kind of how that came about. And then I looked a little bit into The Potter's House organization itself.

Q And what did you learn about the various roles in a relationship between a man and a wife according to that particular religious group?

A It seemed pretty strict organization where the woman would remain subservient to the man, stay at home, raise the kids type situation where the man would provide, go to work and provide. And obviously they were not to live in a life of sin such as drinking, smoking, tattoos were looked down upon.

Q And during the course of your investigation did you learn that actually Troy White and Echo White abided by those two different roles, meaning Echo White stayed at home with the children while Troy White was the provider and worked?

A Yes.

Q Getting back to Prescott, Arizona though. You mentioned that you went down, with CSA Branley was it, to Prescott, Arizona?

A At the time Branley, yes. Tracy Branley.

Q And what was the purpose of going down there?

A Well, a couple of things we wanted to do. Obviously we were still looking for evidence in our case. We were still missing a firearm. We would obviously like the chance to talk to Mr. White about what happened. And basically continue to gather evidence at that location to help try and determine what had happened here in Las Vegas.

- Q And you eventually made it down there?
- 8 A Yes.

- Q Did you conduct a search with CSA Branley or CSA Kruse of the 2008 Dodge Durango that officers in Prescott, Arizona had taken into custody?
- 12 A Yes, we did.
 - Q And did you find the firearm?

- 16 A Yes, it was.
- Q After you returned to Las Vegas did you request any testing to be done on that firearm?

But that where we are at 23 I knew the State might not like the photographs. 24 with it. 25 That's why I asked to approach rather than putting them up.

Mr. Coffee mentioned that these photos -- photos are used to establish relationships, and that may be very true. But we have to remember the source of these photographs are from the victim's iPhone. What Mr. Coffee I think is trying to say is that these photographs effected the defendant's state of mind. He's seeing his wife in these photographs. All of these photographs are with Echo Lucas-White with her boyfriend, but they're on her phone. If they're to affect the state of mind of the defendant they had to have been seen by the defendant.

THE COURT: Well, they can -- wait. They can be text messages to him, they can be posted on Facebook pages, there's lots of ways they can be transmitted. And I haven't heard the information from the detective that tells me any of that stuff.

MR. ROGAN: All right.

THE COURT: Even the victim could show them on the iPhone, too.

MR. ROGAN: Correct. And that's my point. I think that that has to be shown in order for these photos to be admitted. More than --

And that was collected during the search of Herman 14 Allen's house? 15 16 Α I believe so, yes. And you don't know actually who wrote that down? 17 Q No, I don't. 18 Α Who wrote those things down. You don't know 19 Q actually whether these bills were paid? 20 21 Α No. But you knew there was an arrangement that the 22 defendant would pay for the bills at the house where Echo was 23 24 living with their five children? 25 Α Yes.

Were you aware that there was this arrangement so Q 1 that the defendant would not have to pay child support to Echo It's okay if you weren't. 3 Lucas? 4 I can't say that I recall knowing that information. 5 Mr. Coffee brought up that there's a little bit of Q 6 confusion about the number of bullets that were fired from the 7 defendant's gun inside 325 -- or the address at 325 Altamira 8 Road? Correct. Α 10 You knew that they had found three shell casings? Q 11 Yes. Α 12 Three cartridge casings in the house? Q 13 Yes. Α That there was a bullet hole through a mirror that 14 Q -- and a bullet recovered just outside that hole in the 15 16 driveway? 17 Yes. You knew that Joseph Averman had three Q 5 bullet wounds that you could identify; correct? 6 It's tough to say if you're actually referring to Α each as a bullet wound and if they're related to one another 7 as opposed to just how many holes Mr. Averman had in him. Well, that's the point that I want to get across 0 10 here. 11 Okay. Α Did you see Mr. Averman's injuries either through 12 Q photographs or by seeing Mr. Averman in the hospital himself? 13 I believe the photographs were the only way that I 14 saw the injuries and then talking about it later with him. 15 All right. So you saw a hole in his arm that --16 Q 17 Yes. Α -- Mr. Coffee said was through and through; right? 18 Q Yes. Perforated his arm, yes. 19 Α It's a perforating injury, straight through? 20 Q 21 Correct. Α And you saw photographs of entrance wounds as you 22 Q 23 recall, two of them, two holes in his abdomen? Q And so what you were saying before, if I could just summarize, is that you don't know whether Mr. Averman was falling to the ground and that bullet went -- the through and through shot went through his arm and into his abdomen. Is that the point you're trying to make?

A Correct.

Q So you can't even tell by the number of shell casings that are found or cartridge casings that are found, as well as the number of holes in a person's body how many bullets were actually fired?

A Correct. It's actually very, very difficult in a dynamic scene, a dynamic crime scene where people are moving and multiple shots are being fired. It's really tough to make the relation sometimes between certain holes and as they pass through the body. So very difficult sometimes.

Q All right. And given that you are trying to apprehend the person who committed the offenses that occurred at 325 Altamira, are you at all really concerned with whether a bullet has any tissue or material on it?

A Only if I can see visibly that it had. If there were blood visible on the wall where it passed through or even tissue or blood visible on the bullet itself, then that's

- something that we would have to pay attention to. However, when you look at it and you don't see any tissue or blood on it, then you don't become overly concerned with testing it for bullet -- or blood or anything like that.
- Q Was it important to you at all to test that bullet for blood?
- 7 A No.

How long have you been assigned to that unit? 17 0 I have been a forensic scientist for eight years. 18 19 Prior to working in that unit did you have any other 20 experience as a fingerprint examiner? Not as a fingerprint examiner. Did do some 21 fingerprint work, I was a crime scene analyst with Metro for about three and a half years. 23 Okay. So in total you have approximately 11 and a 24 Q half years with Metro? 25

Q Can you tell us a little bit about your educational background and the training that you had to undergo in order to become a fingerprint examiner.

I have a bachelor's degree with a double major Α Yes. in biology and chemistry. Prior to hiring on as a forensic scientist, like I said, I was a crime scene analyst. that capacity I got quite a bit of experience with photography and processing and comparison, I mean, processing and developing of latent prints, evidence packaging and recovery and things like that. And then after about three and a half years in March of 2007 I tested and promoted into the lab as a forensic scientist trainee in the latent print unit. through an 18 month rigorous training program to qualify me to do independent casework as a forensic scientist to do latent print comparisons. Not so much the field work anymore, but now actually processing and recovering latent prints, comparing latent prints, analyzing them to see if they're of value for comparison, comparing them to known people and then running any unidentified prints into our AFIS databases.

So after that, in December of 2009, I was eligible to test to become a certified latent print examiner, passed that test, so I'm certified with the International Association for Identification. I have taught different course work and latent prints to our own department as well as in Utah and

Phoenix, in Arizona. 1 2 In January of 2013, I became published. And my 3 first article, I did an article called Palm Prints, that's in 4 the Encyclopedia of Forensic Science, and I'm proficiency 5 tested annually. So --6 Okay. And do you also undergo yearly continuing Q 7 education? 8 We have things that we have to maintain, Α We do. which most of it is our proficiency tests that are done every 10 year. 11 And have you testified in the Eighth Judicial Court 12 regarding fingerprint examinations before? 13 Yes, I have. Α How many times have you done that? 14 I think this is my 10th. 15 Α Have you testified at any preliminary hearings or 16 0 17 Grand Jury proceedings within the County of Clark? Yes, I have. 18 Α How many times have you done that? 19 20 Α It's eight or nine for Justice Court and I think five or six for Grand Jury, I forget the number --21 Ms. Carter, I want to direct your attention 22 Okay. to some examinations that you completed in this specific case. 23 Okay. 24 Α 25 The forensic request is a request to have someone 265

like you examine evidence as initiated; correct? 1 2 Α Yes. And that's done by a detective that's assigned to 3 Q the case typically? 4 5 Usually, yes. Α In this case you received a request from a Travis 6 0 7 Ivy; correct? 8 Yes, I did. Α And that was under Event Number 120727-1826? 0 10 Yes, it was. Α 11 Specifically, you were asked to look at a 9 12 millimeter semiautomatic handgun bearing Serial Number 13 TO833791? I don't have the serial number memorized, but I'll 14 trust that it's correct, unless you want me to look at my 15 16 report, but --I'll show you the firearm in a second. 17 Q 18 Α Okay. And you were asked to look at a magazine and twelve 19 9 millimeter cartridges, a magazine and nine 9 millimeter 20 cartridges, and one 9 millimeter cartridge that was packaged 21 by itself; correct? 22 23 That's correct. 24 Can you explain for the jurors what a latent Q fingerprint is. 25

So a latent print, on the skin of our fingers and Α palms also, and the soles of our feet and our toes, we have specialized skin called friction ridge skin. Basically it's raised ridges. Those ridges have patterns and they have features that are unique to each individual. It's similar to a rubber stamp. If I -- or it would take some sort of matrix of oil or sweat and touch a surface, I'll leave an impression of those ridges on that surface. That impression that's left there is called a latent print. Latent by definition means there, present, but not readily visible. So we can enhance it with lighting, different lighting techniques, or powders to stick to those residues, or some chemicals that allow us to see those. So ideally what we're trying to do is visualize that latent print so I can compare it.

- Q And are there certain factors that influence whether or not a latent print is actually left behind?
- A Yes.

- O What are those factors?
- A We have factors, basically five that we talk about. One is the skin itself. So if the skin is damaged in some sort of way or if it's covered with a glove or something, obviously the skin's not going to leave a latent print. Then that matrix, that residue that I was talking about, if the -- again, similar to a rubber stamp, if the ink's dry I can press that stamp on that ink pad all day long and I'm not going to

leave an impression. So if I don't have some sort of residue on my skin I'm not going to leave an impression there, so the residue matters.

The surface itself matters. If the surface is really porous, if it's very -- if it's highly textured, things like that can affect it. If it's nice and smooth and clean, generally it's a better surface for latent prints. How it's touched matters. If I take a nice -- even an ideal surface and I press too hard I can obliterate that ridge detail, when I can just, you know, make it where it's not valuable for an examiner to compare. If I move it around and slide it and do things like that, so how it's touched matters.

And then also time, how much time and the conditions that occur after the latent print is left. So if it's left out in the sun for, you know, three years on the outside of a car, might not have great chances of developing that latent, you know, afterwards. If it was just yesterday inside an environment, might be a little bit better. If it was wiped or left out in the humidity in the rain, so those environmental factors play into -- come into play also.

- Q Okay. You mentioned that the surface of an object will affect whether or not a latent print is left behind?
- A It can, yes.

Q With regards to firearms, are you typically successful in developing usable latent prints?

A No.

Q Why is it that firearms don't typically yield good results for you?

Α There's some factors. Again, this would be just my opinion, every firearm's different. I mean, you know, a firearms manufacturer doesn't want to make a gun that's going to rust right away. So they spray them with different chemicals, there's some polymers on some of the guns, these plastic things that -- plastic coatings that don't really allow things to adhere to them. Often times those areas that are handled in a conventional way to handle a gun are They're textured so we don't drop it easily, so those textured surfaces, again, affect whether a latent print is left. Also, if -- sometimes there's military coatings, there's bluings, there's all kinds of different things that

just inhabit -- or inhibit the residue from sticking which 1 would allow us to develop the latent print. How successful are you typically with recovering Q 4 latent prints from a live cartridge, an unfired round? 5 Very poor, successfully. Not very successful at Α 6 We actually did a study at our lab, too, and the results 7 -- we did a two-year study with -- we looked at the -- of our 8 -- of about 3,000 cartridges, live cartridges that were 9 analyzed, and it was 0.16 percent of those we developed a latent on, so it was so low. We actually have a policy now 10 that we do not process cartridges. 11 A sample limits policy? 12 Q 13 Correct. Yes. Α What about fired rounds? 14 Q 15 Fired rounds is also very low. Α 16 0 And are fired rounds also subject to that sample limit policy? 17 18 Α It is, yes. Meaning you won't test fired rounds either? 19 Q 20 Α Correct. 21 Is the same true for DNA? 0 22 Yes, as far as I know they do not process those. Α 23 Is that because during the firing process things like oils and DNA are destroyed? 24 25 I would assume for DNA. DNA does not like high
