## **ASM NATIONWIDE CORPORATION'S ANSWER TO PETITION FOR WRIT OF MANDAMUS**

ASM Nationwide Corporation d/b/a Silverado Smokes & Cigars (“Retailer Defendant”) respectfully submits this response to the Order Directing Answer filed by this Court on May 26, 2023.

This Court has directed the real parties in interest to file and serve an answer to the petition for writ of mandamus. Although the Retailer Defendant is listed in the caption as a Real Party in Interest, it does not have an actual, legal interest in the outcome of the petition. Petitioners only seek relief related to the district court orders granting partial summary judgment in favor of Real Parties in Interest Philip Morris USA Inc. and Liggett Group, LLC regarding the Camachos’ negligence claim and request for punitive damages. *See* Pet. at p.1. Petitioners do not seek to vacate any order issued in favor of the Retailer Defendant. In fact, Petitioners are no longer seeking punitive damages against the Retailer Defendant, 58 PA 8862-8863, and never asserted a negligence claim against the Retailer Defendant. Accordingly, no answer to the petition by the Retailer Defendant is required.

To the extent the Retailer Defendant has standing to answer, it hereby joins in the answer which will be filed by Real Party in Interest Philip Morris USA Inc. pursuant to the Order Granting Motions (relating to Philip Morris USA Inc. and

Liggett Group, LLC's Motions for Extension of Time) filed by this Court on June 16, 2023.
