When I filed 5-11-2023 appeal to Supreme Court I attached with the support documents of DEFENDANT'S BRIEF and DEFENDANT'S EXHIBIT APPENDIX. Both documents were returned to me marked unfiled.

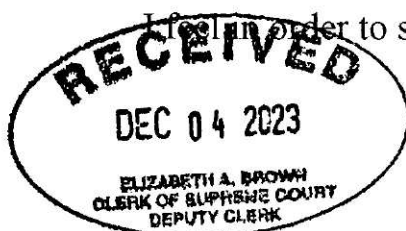
As I argued in my 8-24-2023 letter, district court weed out many Ruorong Yu's fabricated claims, then issued the 7-8-2021 ORDER, only considering the issues mentioned in the order, and order the parties filed their BRIEF to presenting their arguments. To ensure the Honorable Judges in Supreme Court could review those documents, with this letter I attached the related documents and court orders again for your Honor to review.

7-8-2021 Court Order issues No. 1 and No. 2 were plain and simple; GE Interest Plus account was a community property. The moneys deposited into Synchrony Band and Gain Capital were from GE account. After the GE account settlement agreement was signed, Ruorong Yu received half of her share of \$52,788.84, what were have left in Synchrony Bank and Gain Capital were my half of GE money. I presented this fact in my December 22, 2017 filed "Appellant's Informal Brief" page 4 (M) for case 70348 appeal six years ago. As for issue No. 5, \$19,989 shortfall should be offset by 7-20-2017 Court Order allowed Mr. Kurth withdrew \$20,000 from my solely own Synchrony Bank account.

District court 8-11-2023 court order pretty much echoes the fake transcript, ignored the fact that Plaintiff received her fair share of \$52,788.84 half of GE money.
