On July 24, 2023, Transcript Video Services received a request for an estimate of transcripts from Amy Colleen Hanley for the following proceedings:

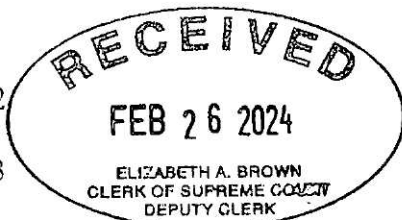
