

It having come to the attention of the Court that Mr. O Keefe filed the instant Motion to Vacate Judgment (NRS 176.555) on June 10, 2022, and the State of Nevada filed its opposition to said motion on June 30, 2022, and the same being scheduled for hearing on July 6, 2022. The Court, having considered all papers and pleadings, hereby DENIES the motion and VACATES the hearing scheduled for July 6, 2022. It is unclear what type of pleading Mr. O Keefe intended. There was no statutorily recognized pleading known as Motion to Vacate Judgment when the judgment is the result of a jury trial. See NRS 176.515. Mr. O Keefe cites NRS 176.555 in the motion s title this statute permits a court to correct an illegal sentence. NRS 176.555 provides that the court may correct an illegal sentence at any time. The grounds to correct an illegal sentence are narrow. See Edwards v. State, 112 Nev. 704, 708, 918 P.2d 321, 324 (1995). A motion to correct an illegal sentence is an appropriate vehicle for raising the claim that a sentence is facially illegal at any time. Such motion cannot be used for challenging the validity of a judgment of conviction or sentence based on alleged errors at trial. Id. Here, Mr. O Keefe does not allege that his sentence is at variance with the controlling statute, that the court was acting beyond its jurisdiction, or that his sentence is in excess of the statutory maximum. Therefore, the allegations at hand are out of the narrow scope allowed in this type of motion. Here, Mr. O Keefe s sentence is within the sentencing range set by the statute. The Motion fails on this front. If Mr. O Keefe intended the instant pleading to be a post-conviction petition for writ of habeas corpus, the motion does not conform with requirements of NRS Chapter 34. Even if the motion did comply with the requirements under the NRS, it would be procedurally barred as untimely under NRS 34.726 and successive under NRS 34.810. Mr. O Keefe must demonstrate good cause and prejudice before the claims could be considered on their merits. The pleading substantively appears to be most similar to a motion to establish factual innocence as Mr. O Keefe claims to be innocent of burglary. However, the pleading does not meet the required standards of NRS 34.900-990. First and foremost, Mr. O Keefe has previously filed such a petition before the Court and it was properly denied, NRS 34.920 defines factual innocence to mean that a person did not: 1. Engage in the conduct for which he or she was convicted; 2. Engage in conduct constituting a lesser included or inchoate offense of the crime for which he or she was convicted; 3. Commit any other crime arising out of or reasonably connected to the facts supporting the indictment or information upon which he or she was convicted; and 4. Commit the conduct charged by the State under any theory of criminal liability alleged in the indictment or information. Here, Mr. O Keefe s claims fail again as the conviction for misdemeanor Battery could have been a predicate offense for Burglary. The applicable statute was in effect from 1995-2005. Furthermore, pursuant to NRS 176.515, a motion for a new trial based on newly discovered evidence may be made only within two years after the verdict of guilt. Mr. O Keefe s case had a jury verdict on October 28, 2004. This Motion does not comply with the NRS 176.515 requirement and also fails for this reason. Due to the aforementioned reasons, Mr. O Keefe s Motion to Vacate Judgment (NRS 176.555) is DENIED. The hearing scheduled for July 6, 2022, is hereby VACATED. The State is to prepare the order. - It having come to the attention of the Court that Mr. O Keefe filed the instant Motion to Vacate Judgment (NRS 176.555) on June 10, 2022, and the State of Nevada filed its opposition to said motion on June 30, 2022, and the same being scheduled for hearing on July 6, 2022. The Court, having considered all papers and pleadings, hereby DENIES the motion and VACATES the hearing scheduled for July 6, 2022.

It is unclear what type of pleading Mr. O Keefe intended. There was no statutorily recognized pleading known as Motion to Vacate Judgment when the judgment is the result of a jury trial. See NRS 176.515. Mr. O Keefe cites NRS 176.555 in the motion s title this statute permits a court to correct an illegal sentence. NRS 176.555 provides that the court may correct an illegal sentence at any time. The grounds to correct an illegal sentence are narrow. See Edwards v. State, 112 Nev. 704, 708, 918 P.2d 321, 324 (1995). A motion to correct an illegal sentence is an appropriate vehicle for raising the claim that a sentence is facially illegal at any time. Such motion cannot be used for challenging the validity of a judgment of conviction or sentence based on alleged errors at trial. Id. Here, Mr. O Keefe does not allege that his sentence is at variance with the controlling statute, that the court was acting beyond its jurisdiction, or that his sentence is in excess of the statutory maximum. Therefore, the allegations at hand are out of the narrow scope allowed in this type of motion. Here, Mr. O Keefe s sentence is within the sentencing range set by the statute. The Motion fails on this front.

If Mr. O Keefe intended the instant pleading to be a post-conviction petition for writ of habeas corpus, the motion does not conform with requirements of NRS Chapter 34. Even if the motion did comply with the requirements under the NRS, it would be procedurally barred as untimely under NRS 34.726 and successive under NRS 34.810. Mr. O Keefe must demonstrate good cause and prejudice before the claims could be considered on their merits.

The pleading substantively appears to be most similar to a motion to establish factual innocence as Mr. O Keefe claims to be innocent of burglary. However, the pleading does not meet the required standards of NRS 34.900-990. First and foremost, Mr. O Keefe has previously filed such a petition before the Court and it was properly denied. NRS 34.920 defines factual innocence to mean that a person did not:

- 1. Engage in the conduct for which he or she was convicted;
- 2. Engage in conduct constituting a lesser included or inchoate offense of the crime for which he or she was convicted;
- 3. Commit any other crime arising out of or reasonably connected to the facts supporting the indictment or information upon which he or she was convicted; and
- 4. Commit the conduct charged by the State under any theory of criminal liability alleged in the indictment or information.

Here, Mr. O Keefe's claims fail again as the conviction for misdemeanor Battery could have been a predicate offense for Burglary. The applicable statute was in effect from 1995-2005.

Furthermore, pursuant to NRS 176.515, a motion for a new trial based on newly discovered evidence may be made only within two years after the verdict of guilt. Mr. O Keefe s case had a jury verdict on October 28, 2004. This Motion does not comply with the NRS 176.515 requirement and also fails for this reason.

Due to the aforementioned reasons, Mr. O Keefe s Motion to Vacate Judgment (NRS 176.555) is DENIED. The hearing scheduled for July 6, 2022, is hereby VACATED. The State is to prepare the order. It is so ordered.
