MOTION TO UNSEAL APPENDIX VOLUMES 11-16

COMES NOW, Appellant, RODERICK STEPHEN SKINNER, by and through KARLA K. BUTKO, Esq., court-appointed counsel, as prepared and submitted by KARLA K. BUTKO, Esq., and hereby requests that this Court unseal Volumes 11-16 of the Appendix filed into this record. Counsel has been unable to review those pages of this appellate record in order to prepare the Opening Brief.

Counsel notes that Volume 10 of the Appendix is properly sealed as the district court clerk filed into the record the presentence report and the psychosexual evaluation required by law. Those items are properly sealed and usually transmitted to this Court by way of

Also difficult to understand are the page numbers for Volumes 11-16. The numbering system seen in the appeal index makes no logical sense. Volume 2 should be pages 250-500. Yet, it appeared that volumes 11, 12, and 13 have the same page numbers. Volume 3 should be 501-750. It appears that volumes 11, 12, and 13 will have the same numbers. Volume 4 should be 751-1000. Yet, those pages are found in volumes 13, 14, 15, and 16. As the court will note, it will be this attorney's issue to straighten this out. In order to do so, access to the sealed volumes is necessary.

Jennifer P. Noble, Chief Appellate Deputy District Attorney for Washoe County, has advised that she has no objection to unsealing the appendix, as long as those volumes do not contain pornography or otherwise properly sealed items.
