- (2)(I) if the application is made by the attorney, he must include in an affidavit the address or last known address at which the client may be served with notice or further proceedings taken in a case in the event the application for withdrawal is granted, and he must serve a copy of the application upon the client and all other parties to the action or to their attorneys.
