Appellant STEVEN EGGLESTON hereby moves for leave to file the documents included in all volumes of Appellant Steven Eggleston's Appendix to Opening Brief ("Appellant's Appendix") under seal. This Motion is made and based upon SRCR 3, NRS 432B.280, NRAP 27, the following Memorandum of Points and Authorities, the pleadings and papers on file herein, and any argument presented at the time of hearing on this matter (if any).

MEMORANDUM OF POINTS AND AUTHORITIES

I. PROCEDURAL HISTORY

In the District Court action below – *Steven Eggleston vs. Clark County Department of Family Services*, Carson City District Court Case No. 20 OC 00164

1B ("District Court Action") – Respondent filed an Ex Parte Motion and Order to Seal Court Records. As part of that filing, District Court Judge James E. Wilson entered an Order to Seal Court Records, which reads in pertinent part as follows:

THE COURT HEREBY FINDS that the records in this case contain information deemed confidential pursuant to NRS 432B.280;

THE COURT FURTHER FINDS the public interest in privacy or safety interests outweighs the public interest in open court records because the records in this case are confidential by law;

THE COURT FURTHER FINDS sealing the court records in this case is required by state law;

In accordance with Part VII of the Supreme Court Rules, and until further Order of this Court, **IT IS HEREBY ORDERED**, that the court records in this case, including the record of proceedings and pleadings, that contain confidential information be SEALED.

Id. at p. 4 (emphasis in original).

Attached hereto as **Exhibit 1** is a true and correct copy of the Docket Sheet of the District Court Action (as of November 1, 2023). The Docket Sheet lists the Ex Parte Motion and Order to Seal Court Records (No. 81, filed February 12, 2021), as well as the Order Denying Our Nevada Judge's Motion to Unseal (No. 31, filed December 22, 2022) and the Order Denying Second Motion to Unseal (No. 20, filed April 28, 2023).

II. LEGAL ARGUMENT

Pursuant to SRCR 3(4), which sets forth grounds to seal or redact court records when a person files a motion requesting same, the public interest in privacy or safety interests outweighing the public interest in open court records include findings that:

- (a) The sealing or redaction is permitted or required by federal or state law;
- (b) The sealing or redaction furthers an order entered under...a protective order entered under NRCP 26(c)...;
- (c) The sealing or redaction furthers an order entered in accordance with federal or state laws that serve to protect the public health and safety;
- (d) The redaction includes only restricted personal information contained in the court record;

. . .

(h) The sealing or redaction is justified or required by another identified compelling circumstance.

NRS 432B.280, which governs the confidentiality of information maintained by an agency which provides child welfare services, states:

- 1. Except as otherwise provided in NRS 239.0115, 432B.165, 432B.175 and 439.538 and except as otherwise authorized or required pursuant to NRS 432B.290, information maintained by an agency which provides child welfare services, including, without limitation, reports and investigations made pursuant to this chapter, is confidential.
- 2. Any person, law enforcement agency or public agency, institution or facility who willfully releases or disseminates such information, except:
- (a) Pursuant to a criminal prosecution relating to the abuse or neglect of a child;
- (b) As otherwise authorized pursuant to NRS 432B.165 and 432B.175;
- (c) As otherwise authorized or required pursuant to NRS 432B.290;
- (d) As otherwise authorized or required pursuant to NRS 439.538; or
- (e) As otherwise required pursuant to NRS 432B.513, is guilty of a gross misdemeanor.

See State Div. of Child & Family Services, Dept. of Human Res. v. Eighth Judicial Dist. Court of State ex rel. Cnty. of Clark, 119 Nev. 655, 659, 81 P.3d 512, 514 (2003) (confirming the confidentiality of such records subject to statutory exceptions).

Here, Judge Wilson considered SRCR 3(4) and NRS 432B.280 in ordering the entirety of the records in the District Court Action sealed. Thus, the public's interest in privacy or safety interests under SRCR 3(4)(a)-(d) and/or (h) continue to outweigh the public's interest in open court records as to these same records.

Appellant is providing Respondent and the Court with the documents to Appellant's Appendix for this Court to review.

III. CONCLUSION

Based on the foregoing, the Court should grant the Motion and seal all the appendix documents, which remain confidential for a reasonable period of time until the Court rules on the Motion.
