Original complaint was filed on 8/4/23 in District 2, Dept 1, it was then moved to Carson City JD 1, Dept 1, Judge Russell dismissed the entire case with prejudice on 11/20/23

10. Provide a brief description of the nature of the action and result in the district court, including the type of judgment or order being appealed and the relief granted by the district court:

This is an appeal of the Order dismissing the complaint with prejudice.

Appellant filed a complaint and supplemental exhibits on August 4, 2023, and more supplemental exhibits on August 9 in Washoe County JD 2, Dept 1.

Numerous motions from both sides were filed, as the court docket shows. Beadles filed a motion to change the venue to Lyon County. Judge Drakulich granted the motion to change venue, citing the law, but she misapplied it, moving it to Carson City where Beadles had no chance of a fair trial. Beadles then filed another motion for a change of venue in Carson D1, Dept 1, to which the defense filed an

opposition. Oral arguments occurred on November 20, 2023. Beadles' fears of bias were confirmed when Judge Russell lied to the court, showed extreme bias, a total disregard for case law, authorities, statutes, rules, laws, etc., and dismissed the entire case, with prejudice, clearly violating Beadles' rights, and the rule of law. Russell has now created case law that shows court orders in Nevada no longer need to be enforced or even recognized in Nevada Courts. Beadles is now seeking an expedited appeal from the Supreme Court of Nevada, as the issues presented in his case and over 160 exhibits clearly demonstrate the dire need to address his allegations and findings well before the 2024 elections to prevent irreparable harm to the Plaintiff and the public. It is critical this case, the respondents, and Judges' actions and inactions are addressed by this Honorable Court prior to the 2024 election, as failing to do so would indicate there is no longer rule of law in Nevada. In the absence of this Honorable Courts intervention, the integrity of the upcoming election in Washoe County will be compromised, this is good cause to expedite the briefing schedule.




