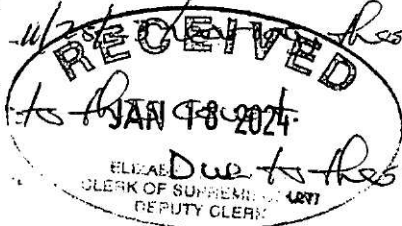

Pro se Rule 60B Motion to

Correct a Mistake

This pro se Rule 60B Motion to Correct a mistake comes about due to this court dismissing Appellant's notice of appeal stating his 30-day appeal period began on 10/17/23 when, in fact, the district court had scheduled a new hearing on the matter for 11/28/23. Thus, showing the district court had not made its final judgment on the matter until 11/28/23. Therefore, Appellant's 30-day appeal period should not have begun until Appellant received the district court's final judgment on 12/5/23. Which would make Appellant's notice of appeal, filed on 12/11/23, timely.

Furthermore, had Appellant filed his notice of appeal prior to the district court's hearing on 11/28/23, that court would have cancelled said hearing claiming that justice action had been transferred to the Nevada Supreme Court. The district court took that exact action against Appellant in a prior court action. Also, had the district court ruled in Appellant's favor at the 11/28/23 hearing, there would be no cause for Appellant to appeal.
