MOTION FOR EXTENSION QUIPINE COURT TO FILE AMICUS BRIEF OF THE NEVADA JUSTICE ASSOCIATION

The Nevada Justice Association (NJA), an amicus curiae, is a non-profit organization of independent lawyers in the State of Nevada. NJA is represented in this matter by Tom W.
