MEMORANDUM OF POINTS AND AUTHORITIES

Every Appellant is free to consider their appeal, and their conception of the issues therein, as singularly novel and important, as DailyPay here apparently does. But in truth it makes a single subject violation claim where only a single subject appears; the same description of effect claim that every appellant makes; and a “full text” argument unsupported by any precedent this Court has ever issued. Beyond that, this Court has already had occasion to consider most if not all of the issues involved in this appeal in Case No. 88526. When set against the rights of initiative proponents to have their litigation resolved in an expeditious manner, DailyPay’s arguments against the present motion are not very persuasive, and reveal instead the intentions this Court has warned of, namely tactical delay.
