



ORDER CREATING COMMISSION TO STUDY
JUDICIAL BRANCH SECURITY

On July 22, 2024, Elissa F. Cadish, Chief Justice, Nevada Supreme Court, filed a petition seeking to create a Commission to Study Judicial Branch Security (Commission) to study and make recommendations regarding information gathering and sharing, training security officers and judicial officers, identifying and categorizing threats, responding to threats and violence, courthouse security, and interfacing with other branches of government.

Having considered the petition, we conclude that such a commission should be created. The Commission shall conduct all hearings in public and post all meeting minutes and documents considered by the Commission on the Supreme Court's website.

Associate Justice Linda Marie Bell is hereby appointed as chair of the Commission. Chief Marshal James Wright is hereby appointed as vice chair of the Commission. The individuals listed in Exhibit A are appointed to the Commission, effective immediately. Thereafter, if needed,

the Chief Justice will enter an order appointing members to the Commission pursuant to NRAD 7.1.

The Commission shall file a report with this court on its findings and recommendations no later than February 28, 2025.
