NRAP 16(e)(1). A settlement statement is limited to 4,667 words, unless otherwise directed by the settlement judge. NRAP 16(e)(2). Sections 1-4 of the settlement statement must be served on opposing counsel and the settlement judge. Id. Sections 5-10 should be served on the settlement judge only. Id. The settlement statement must not be filed in the Supreme Court. See NRAP 16(e)(1). - > All counsel shall participate in a pre-mediation conference initiated by the settlement judge within 30 days of this Notice. See NRAP 16(c).
- > All papers or documents filed with the Supreme Court while a case is in the settlement program shall be served on all parties and the settlement judge. See NRAP 16(f).
