3 out of the office attending to medical appointments;


4 4. That this request still allows for the

11 Deputy have also taken time from writing;


12 6. That Respondent has stipulated to the  
13 requested extension;

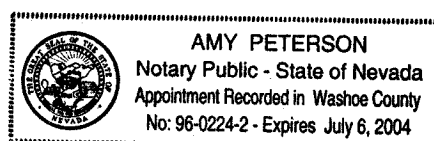
14 7. That this motion for an extension of time


