1 District Court Clerk's office. Currently, one section of the file is missing, and counsel has been  
2 unable to determine the contents of that missing portion.

3 Specifically, more time is needed to research the appeals and other related  
4 proceedings of co-defendants. This case was originally brought against six defendants and tried
