**ORDER DENYING MOTION FOR PARTIAL STAY AND MOTION TO PRODUCE  
DISCOVERY, ORDER FOR WITHDRAWAL OF COUNSEL**

The Court has read and considered Petitioner's Motion for Partial Stay of Execution of Sentence, Motion to Produce Specifically Requested Discovery Information, Motion for Withdrawal of Attorney, filed October 7, 2002; and all supporting documents.

In Passanisi v. State, 108 Nev. 318, 322-23 (1992), the Court held that the district court lacks jurisdiction to suspend or modify a sentence after the defendant has begun to serve it, pursuant to NRS 176A.400, unless the court has made a mistake in rendering the judgment which works to the extreme detriment of the defendant and which constitutes a violation of due process. Such violations of due process arise only when errors result in materially untrue assumptions about the defendant's record. Here, Petitioner requests a stay of fees ordered in his sentence because he cannot afford to pay them. Pursuant to


1 Passanisi and NRS 176A.400, the Court does not have jurisdiction to grant this request,  
2 and the request must be denied.

3 Petitioner's Motion to Produce Discovery must also be denied, pursuant to the  
4 Nevada Supreme Court's finding that the secret witness report, the subject of Petitioner's  
5 Motion to Produce, would not have changed the outcome of the proceeding (January 17,  
6 2002 Order of Affirmance at 3).

7 Finally, Petitioner's Motion for Withdrawal of Attorney is granted pursuant to SCR 46,  
8 and Petitioner is substituted in pro per.

9 NOW THEREFORE, IT IS HEREBY ORDERED that Petitioner's Motion for Partial Stay  
10 and Motion to Produce Discovery are both denied. Petitioner's Motion for Withdrawal of  
11 Attorney is granted.
