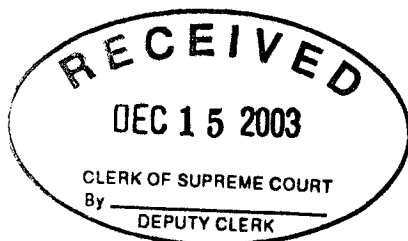
COMES NOW, Appellant, GREGORY SCOTT HERMANSKI, in Pro Se,

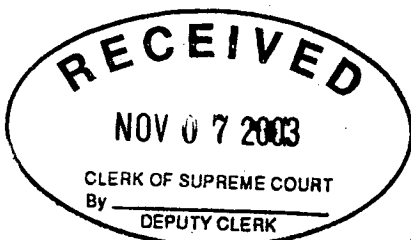
Dear Clerk,

Thank you for your letter of September 24, 2003. This is to express my concern to the court that my attorney, Paul E. Wommer, has not only failed to perfect my appeal, but has also failed to comply with the Court's order entered August 21, 2003, wherein the Court directed Mr. Wommer to comply with the Court's order of July 22, 2003.
