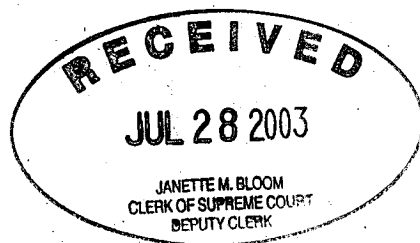



1 IT IS HEREBY ORDERED that the Defendant's Pro Per Motion for Leave to Proceed  
2 in Forma Pauperis, shall be, and it is hereby granted.


3 As to Defendant's Pro Per Motion for Modification of Sentence: Court noted  
4 Defendant does not indicate where this Court would have jurisdiction; that he does not show  
5 material fact at the time of sentencing. Court reviewed the file and stated a writ would have  
6 been the proper vehicle for Defendant's allegations. Defendant stated he was not interviewed  
7 by Parole and Probation, however, Court noted that Defendant never made the Court aware  
8 that he was not. Defendant stated he had a problem with the text of the Pre-sentence Report.

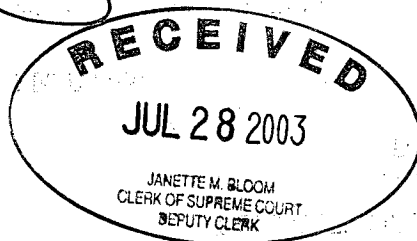
