**APPELLANT'S RESPONSE TO  
ORDER TO SHOW CAUSE**

On December 19, 2012, this Court entered an Order to Show Cause directing Appellant Steven C. Jacobs ("Jacobs") with 11 days to show reason why this appeal should not be dismissed for lack of jurisdiction as to Las Vegas Sands Corp. and Sands China, Ltd.

In response, Jacobs agrees that neither Las Vegas Sands nor Sands China are proper Respondents in this action, as further evidenced by the fact that neither Las Vegas Sands nor Sands China has participated in this appeal, which is now fully briefed. The District Court's underlying Order is certified as final only as to

1 Respondent Sheldon Adelson ("Adelson"). As the District Court correctly  
2 recognized, its order disposed of Jacobs' entire claim for defamation. This was  
3 Jacobs' only claim against Adelson, and is sufficiently distinct from the other  
4 rights asserted in this action. Accordingly, there was "no just reason" to delay  
5 final judgment as to Adelson.

6 In light of this, Jacobs' Opening and Reply Briefs only address Jacobs'  
7 claim against Adelson. In the face of this Court's Order, Jacobs' counsel realizes  
8 that Las Vegas Sands and Sands China are erroneously identified as Respondents  
9 in the caption of the briefs by mistake. Las Vegas Sands and Sands China are not  
10 parties to this appeal.
