This was 2 Jacobs' only claim against Adelson, and is sufficiently distinct from the other 3 rights asserted in this action. Accordingly, there was "no just reason" to delay 4 5 final judgment as to Adelson. In light of this, Jacobs' Opening and Reply Briefs only address Jacobs' 6 claim against Adelson. In the face of this Court's Order, Jacobs' counsel realizes 7 8 that Las Vegas Sands and Sands China are erroneously identified as Respondents 9 in the caption of the briefs by mistake.
