On pages 6, 7, and 13 of Steven C. Jacobs' Reply, he cites and discusses the New Mexico case of *Helena Chemical Co. v. Uribe*, 255 P.3d 367, 373-74 (N.M. 2011), as a decision of the New Mexico Supreme Court. According to Jacobs, *Uribe* rejects Adelson's "theory of privilege" and illustrates that "Adelson's fondness for Texas law" should not influence this Court in deciding Jacobs' appeal. Reply at 6; 7, 13. Two supplementary points are in order about Jacobs' reliance on *Uribe*:

- (1) the *Uribe* decision cited and quoted from by Jacobs was that of the Court of Appeals which *reversed* the district court's grant of summary judgment for the defamation defendants; and
- (2) The New Mexico Supreme Court *reversed* the Court of Appeals and affirmed "the district court's grant of summary judgment . . . because the four statements at issue," including

"statements made during a press conference, . . . are absolutely privileged."

Helena Chemical Co. v. Uribe, 281 P.3d 237, 247 (N.M. 2012).
