## **MEMORANDUM**

I, NANCY A. BECKER, am the supervising attorney in the above-captioned case. This Court can extend the time to file a Fast Track Response upon demonstration of extreme need or merit. NRAP 3C(h)(2). No previous extensions have been granted to the State. Prior to the filing of this Fast Track Statement, Appellant received an extension of time from the Court.

As good cause for the extension, the State cites the number of issues set forth, the size of the record and the Nevada State Bar examination. This case consists of a three (3) volume appendix—consisting of 494 pages. The seventeen (17) page Fast Track Statement raises approximately four (4) issues and three (3) sub-issues.
