PLEASE TAKE NOTICE THAT on January 24, 2013, defendants filed an emergency writ petition requesting action by February 4, 2013, the date by which privileged documents were ordered produced under the district court's January 18 order. (Doc. # 2013-02469). In the writ petition, defendants advised the court of their pending motion to stay before the district court. Defendants' motion to stay was heard on January 29 and the district court orally granted a six-month stay.

The written order memorializing the stay and its terms is not yet available, but it will be provided to the Court when it is entered. Defendants provide this notice to advise the Court of the change in the emergency circumstances present at the time the petition was filed.<sup>1</sup>
