Pursuant to NRAP 27(d)(2), Petitioners Las Vegas Sands Corp. ("LVSC") and Sands China Limited ("SCL"), collectively referred to as "defendants," respectfully move Court to allow them to file a reply in support of their motion for a stay in excess of five pages.

On June 28, 2013, defendants filed a six page emergency motion asking this Court to grant an emergency stay of the district court's June 19, 2013 Order. The same day, the Court granted a temporary stay pending receipt and consideration of any opposition to the stay.

On July 3, the real parties in interest submitted an over-length twenty-four page opposition to the stay, along with a motion to allow the filing of it. The Court granted the motion, and the opposition was filed on July 22. In order to adequately respond to the lengthy opposition, defendants ask the Court for permission to file four and a half more than the five pages allowed under NRAP 27(d)(2) for their reply.

Defendants respectfully ask the Court to grant this Motion and accept their nine and a half-page reply (submitted concurrently with this motion) for filing.

This Motion is based on NRAP 27(d)(2), the attached declaration of Steve Morris, and the papers and pleadings on file with the Court.


2. I have personal knowledge of following and am competent to testify thereto.
