Between January and June 2013, Petitioner filed three writ petitions challenging three separate but related discovery orders of the district court in the underlying case, *Jacobs v. Las Vegas Sands Corp. and Sands China Ltd.*<sup>1</sup> The orders exceed the scope of the Order of August 26, 2011 by which this Court issued a Writ of Mandamus directing the district court to "hold a evidentiary hearing on personal jurisdiction" over Sands China, Ltd. ("SCL"), "and to stay the action as set forth in the order until after entry of [the district court's] jurisdiction decision." Order (Doc. 11-26107) and Writ of Mandamus (Doc. 11-28569). An evidentiary hearing on jurisdiction has yet to be held.

On August 8, 2013, this Court denied Petitioner's Motion to Consolidate the three writ petitions but stated that the petitions would "nonetheless be clustered based on any overlapping legal issues." (Doc. 13-23251). Petitioners respectfully ask the Court to allow them to present oral argument on the two remaining petitions. Writs 2 and 3 are substantively related; both are fully briefed and are in the Court's screening process. The two remaining petitions address questions of privilege that the district court did not need to address to determine whether SCL is subject to jurisdiction in Nevada. The two pending petitions, like the first in No. 62489, also raise a reasonable question about the efficient management of this case following the Court's August 2011 Remand Order.

Scheduling oral argument on the two remaining petitions would enable the Court to resolve the pending issues "in a consistent and efficient manner." 8/8/13 Order (Doc. 13-23251, citing IOP 2(c)(2)).
